#### **BLUF**

- An individual, using the moniker pauly\_creepo666, and who appears to have been present during the Saturday 5/30/20 violence, posted several pictures and videos to Twitter and Instagram of possible criminal activity. Unclear if the photos are of the poster themselves or of other threat actors.
- While overnight social media activity was very light, the SOMEX team did find some tweeting by individuals stating they would monitor police radio activity and provide police comms to others

#### **EAST SIDE**

**Spokane RA** – NSTR.

**Yakima RA** – False online reports of ANTIFA/protestors in the outlying areas of a city are causing citizens to call the police and report non-existent protestors. This has the effect of drawing police away from actual protests.

Yakima Police department report that an unknown individual entered Lotsa Guns Nstuf, 1701 S. 1st street yakima on 6/1/20. Individual was on phone at time and providing intel regarding store personnel, layout, security and inventory to person on phone. Store employee confronted individual who would not answer specific questions and quickly left.

**Tri-Cities RA** – Black Lives Matter march planned for Saturday, 11am beginning at the Winco store on Clearwater Avenue. Amber

Rodriguez is the organizer.

An Anti-ANTIFA group, 'Defend the Tri' is made up of armed citizens. Approx 150-250 members were out last night at a Best Buy store when rumors spread it was going to be looted. Members of the group have been pulling up behind officers during traffic stops, armed, telling the officers "I got your back." This is giving concern to the local police about a miscommunication/incident.

**Seattle** – An individual, using the moniker pauly\_creepo666, and who appears to have been present during the Saturday 5/30/20 violence, posted several pictures and videos to Twitter and Instagram of possible criminal activity. Unclear if the photos are of the poster themselves or of other threat actors. Information has been entered into SOMEX and lead tracking sheet, with recommendation to serve preservation letters.

It looks like they are trying to create a calling tree for calls to action, in this case it's an anti-government group, but seems like it could be used by any groups trying to avoid social media detection. Just a heads up in case it's something you haven't seen before.

This occurred approximately 2130 on 01 June. SA was treated for injuries and is resting at home.
