On July 17th, 2020 a rally was held at the Snohomish County Complex located at 3000 Rockefeller Ave, Everett, Washington. The permitted rally was a "Back the Blue" event which drew opposition protestors. The above individual was standing on the sidewalk in a manner that was seemingly security related (back to the event, opposite side of the street of the opposition protestors).

A physical confrontation erupted, and this individual put a protestor in a headlock followed by displaying a pistol for a few moments as the crowds reacted to the confrontation and the tension escalated. Law enforcement responded, but the subject was not contacted or identified. No shots were fired and the weapon was drawn and secured on the right side pocket of the vest. "ANTIFA" is a patch on the right shoulder of the subject. The information has been checked with the event organizers, and the subject is unknown to them.
