

(U) National Crisis Coordination Center Update: Preventing Violence and Criminal Activity January 2021

1700 19 JANUARY 2021

(U//LES) This update was compiled by the Joint Inter-Agency National Crisis Coordination Center in the FBI Strategic Information Operations Center. Information is accurate as of 1400 EST on 19 January 2021. The following agencies contributed to the development of this SITREP: ATF, DEA, DOD, DOJ, DHS, US Park Police, and USMS. Responses provided after the cut-off time will be included in the next SITREP.

(U) The information marked (U//LES) in this document is the property of the FBI and may be distributed within the Federal Government (and its contractors), U.S. intelligence, law enforcement, public safety or protection officials, and individuals with a need to know. Distribution beyond these entities without FBI authorization is prohibited. Precautions should be taken to ensure this information is stored and/or destroyed in a manner that precludes unauthorized access. Information bearing the LES caveat may not be used in legal proceedings without first receiving authorization from the originating agency. Recipients are prohibited from subsequently posting the information marked LES on a website or an unclassified network.

(U//LES) Under FBI policy and federal law, no investigative activity may be based solely on First Amendment activity. The FBI does not investigate, collect, or maintain information on U.S. persons solely for the purpose of monitoring activities protected by the First Amendment. Moreover, the FBI will "maintain no record describing how an individual exercises rights guaranteed by the First Amendment unless expressly authorized by statute or by the individual about whom the record is maintained or unless pertinent to and within the scope of an authorized law enforcement activity." Privacy Act of 1974, section (e)(7).

(U//LES) DIOG Appendix L further restricts the collection of information regarding First Amendment protected activity: the FBI may only collect information relating to the exercise of a First Amendment right if (1) the collection is logically related to an authorized investigative purpose, (2) the collection does not materially interfere with the ability of an individual or a group to engage in the exercise of constitutionally protected rights, and (3) the method of collection is the least intrusive alternative that is reasonable, based upon the circumstances of the investigation. Respondents are reminded that information including tweets, Facebook posts, and "likes" are First Amendment protected speech and "following" and "friending" on social media may be an exercise of the First Amendment freedom of association. The collection of such information therefore requires human review to determine it is pertinent to and within the scope of an authorized law enforcement activity.

(U//LES) Within this legal, and policy framework, the information requested from field offices in this communication is intended to provide timely information to appropriate law enforcement and/or public safety personnel who are authorized to protect facilities, personnel, and the public from imminent threats of violent and/or criminal activity. This document is meant as a summary of significant investigative highlights and NOT as a comprehensive review of ongoing investigations. The information contained in this communication is NOT to be incorporated into any formal or informal written document nor further disseminated without the authorization of the FBI Headquarters, SIOC. Unauthorized use of this information may jeopardize sensitive national security and/or criminal investigations, result in the possible identification and/or physical harm of human sources or create undue notification into the FBI's interest of intended targets.

(U) This communication is intended to provide timely information to appropriate law enforcement and/or public safety personnel who are authorized to protect facilities, personnel, and the public from imminent threats of violent and/or criminal activity. It is related to and within the scope of an authorized law enforcement investigation or investigative activity. Under FBI policy and federal law, no investigative activity may be based solely on First Amendment activity. The FBI does not investigate, collect, or maintain information on U.S. persons solely for the purpose of monitoring activities protected by the First Amendment.

(U) National Crisis Coordination Center (NC3) Executive Summary

(U//FOUO) THE FBI, IN CLOSE COORDINATION WITH ITS FEDERAL, STATE, AND LOCAL PARTNERS, CONTINUES TO MONITOR AND RESPOND TO EVENTS RELATED TO THE VIOLENCE ASSOCIATED WITH LAWFUL PROTESTS.

(U//LES) With the recent threats and civil disturbance at the United States Capitol targeting members of Congress; state, local, and tribal law enforcement jurisdictions are requested to maintain operational awareness of their respective Congressional Representative's district offices and residences for any types of threats or potential criminal activity. At this time, there are no credible threats against any member of Congress.


(U) ELECTORAL CERTIFICATION AND INAUGURATION 2021

- (U//LES) According to open sources, as of 19 January, armed protests are being planned at all 50 state capitols from 16 January through at least 20 January, and at the US Capitol from 17 January through 20 January.
- (U//LES) According to US Park Police and D.C. Metropolitan Police Department, there are 45 planned events in the NCR through 1 February, with estimated sizes of inauguration-related protests ranging from one to 60 committed participants. Twenty-three permit applications listing between four to 5,000 participants were submitted as of 18 January. Planned demonstrations specific to Inauguration Day range in size from one to 897 committed participants with permit applications listing between three to 1,000,000 participants.
- (U//FOUO) As of 19 January, 25,368 National Guard members are providing site security for 28 state capitals. A total of 18,619 National Guard members are on duty in the NCR. As of 18 January, the National Guard in Washington, DC reported attempts by individuals to photograph vehicles and credentials at security checkpoints.
- (U//FOUO) On 16 January, The United States Attorney's Office (USAO) advised all defendants arrested on charges associated with their criminal activity on 6 January at the US Capitol have a stay-away order specific to Washington, DC. USAO DC provided probable cause arrest authority should the FBI identify a defendant attempting to enter Washington, DC.

(U) INVESTIGATIVE INFORMATION

• (U//FOUO) On 6 January, the FBI activated a digital media tip line URL (https://fbi.gov/USCapitol) which opened to the public. As of 0700 on 19 January, the FBI has received more than 202,926 digital media tips.

• (U//LES) As of 0800 on 19 January, approximately 362 persons of interest have been identified as having unlawfully entered the US Capitol. Eighty-nine individuals have been arrested, with an additional 23 outstanding warrants and 20 complaints being reviewed.



(U) National Threat Picture Through Inauguration 2021

(U) CURRENT FLASHPOINTS AND RESPONSES

(U) Potential of criminal offenses or violence related to the 6 January 2021 Electoral College certification of the 2020 Presidential Election results for situational awareness – past/ongoing (within last 12-24 hours) and planned (next 12-24 hours) affiliated with Criminal Offenses, threats of Weapons of Mass Destruction, Counterterrorism, and Federal Law Enforcement Deployments.

(U) UPCOMING FLASHPOINTS AND RESPONSE

(U) Possible catalysts to help understand potential flashpoints for upcoming violence, including anniversaries of past events, ongoing legal cases of past incidents where milestones could result in community reaction, or recent events during criminal activity associated with protests (injuries, etc.) that could spark local responses.

(U) Potential Flashpoints by Geographic Location

- (U//LES) **Nationwide:** As of 15 January, general discussions continued across various RMVEassociated social media groups about the publicized protests/rallies scheduled between 17 and 20 January. There was debate about attendance and there seemed to be a variety of opinions on attendance and the validity of who is organizing these events.
- (U//LES) **Nationwide:** As of 10 January, open sources and social media platforms report messaging for armed protests planned at all 50 state capitols between 16 January through at least 20 January, and at the US Capitol in Washington between 17 January through 20 January.

- (U//FOUO) **California:** As of 16 January, an identified group was planning to counter protestors at the state capitol on 20 January. The identified group planned to start protesting from J Neely Johnson Park at 1000 and had a mutual agreement not to fight National Guard members and instead focus on police and right-wing actors.
- (U//FOUO) **Nebraska:** As of 11 January, law enforcement became aware of an email sent to the Scottsbluff Sheriff's office from an identified organization which indicated they are calling for investigations into voter fraud and a civil war is upon us and that they can, "muster 1000s of patriots to keep the peace."
- (U//LES) **Oregon:** An identified group has made general threats to the Oregon State Capitol since December. A complainant stated the group is planning a takeover of the Oregon Capitol on 20 January. As of 15 January, the identified leader of the identified group has advised all members should stand down and not travel to Salem to commit violence.
- (U//LES) **Texas:** As of 14 January, two identified individuals of a known group made threats to the Austin State Capitol via social media and expressed interest in the building and representatives.
- (U//LES) Texas: As of 19 January, law enforcement received information that an identified individual was planning to go to the Austin State Capitol on 20 January. The individual reportedly purchased two firearms, ammunition, and flex cuffs. Law enforcement is aware and is coordinating this matter.
- (U//LES) Virginia and Washington, DC: According to law enforcement, an identified group is planning a 20 January march from Arlington, VA to "the steps of Joe Biden's illegitimate inauguration." The group claims to have 75,000 attendees. As of 19 January, law enforcement vetted the reporting and deems it aspirational.
- (U//FOUO) **Washington, DC:** As of 13 January, an identified group has shifted their plans from descending on the Capitol to promoting gatherings at several DC-area hotels in an effort to prevent other groups from booking at the hotels. Identified travel companies, hotels, and vacation online rental marketplace companies are weighing the business and safety options for the inauguration.

- (U) **Washington, DC:** As of 8 January, users on two identified social networking sites promoted an identified march on 20 January to prevent the President-Elect from entering the White House. As of 13 January, a social media page indicates 897 people are "going" to the event and approximately 2,300 are "interested."
- (U//LES) **Washington, DC:** On 8 January, the FBI received information on individuals calling for others to join them in "storming" state, local, and federal government courthouses and administrative buildings in the event POTUS is removed as President prior to Inauguration Day. These individuals are also planning to "storm" government offices including in the District of Columbia and in every state, regardless of whether the states certified electoral votes for Biden or Trump, on 20 January.
- (U//LES) **Washington, DC:** On 7 January, the FBI received information about an identified armed group intending to travel to Washington, DC on 16 January. They have warned that if Congress attempts to remove POTUS via the 25th Amendment a huge uprising will occur.
- (U//FOUO) **Washington, DC:** On 8 January, information was received regarding a video posted on an identified website encouraging people to kill Senators and Congress members. The video was threatening violence in Washington, DC on Inauguration day and advised people to bring guns.
 - (U) Threat To Life
- (U//LES) Multiple reports indicate various threats to harm President-Elect Biden ahead of the Presidential Inauguration. Additional reports indicate threats against VP-Elect Harris and Speaker Pelosi.
- (U//LES) **Nationwide:** As of 19 January, 17 FBI field offices are investigating a total of 40 Threat to Life Guardians, including threats toward prominent politicians and law enforcement and their families.
- (U//FOUO) **Nationwide**: An identified post online, which has since been deleted, discussed targeting identified tech companies, data centers, and media companies; to include references targeting employees at their homes and employees' children at their schools. Law enforcement is aware these threats, and as of 19 January, has shared the specific threat information with appropriate personnel of an identified tech company.
- (U//LES) Nationwide: On an identified social networking website, an identified group advised its members that Jewish communities would be vulnerable to attacks while the police and military were preoccupied with the Presidential Inauguration. The identified group emphasized not to go to Washington, DC due to heightened security, but rather focusing on multiple locations where a centralized force would not be able to respond to as quickly. On 18 January, the FBI's Office of Public Affairs and Counterterrorism Division held a call with Jewish organizations Secure Communities Network, the Anti-Defamation League, and the Interfaith Alliance to provide additional details regarding this potential threat.

(U) OTHER

- (U/LES) As of 18 January, preliminary reporting suggests an identified social media platform used by some domestic violent extremists (DVE), including Racially Motivated Violent Extremists (RMVEs), are warning participants that law enforcement is conducting interviews. Additional social media messaging suggest that individuals should record their interviews with law enforcement and share the questions with the group.
- (U//FOUO) As of 18 January, an identified international hotel chain received similar bomb threats in three states and Washington, DC with a computerized voice stating, "Bombs have been placed at all Trump Properties to be detonated at an opportune time. This is just the beginning." Bomb sweeps were conducted with negative results.
- (U//LES) According to law enforcement partners, some members of identified groups that attended the 6 January events had planned to use specific radio frequencies for their communication. This information was shared with DC's Office of Unified Communications to program some handheld radios, which were given to US Capitol Police and the Metropolitan Police Department, for monitoring. For additional information related to this topic and tactic please see FBI product titled "Domestic Violent Extremists' Use of Amateur HAM Radios for Communication and Other Pre-Operational Planning" (17 January; SIR-00340433389).
- (U//LES) Mixed reporting is indicating an identified group to "prepare for potential conflict in response to National Guard troops being activated in Washington, DC," while other reporting is indicating the identified group to stand down. As of 14 January, the identified group leadership issued flyers instructing members to stand down until 4 March.


(U) STATE AND LOCAL SURVEY RESPONSES

(U) The Office of Partner Engagement (OPE) disseminated a nationwide survey <u>https://arcg.is/14fOiz</u> to state and local partners to capture law enforcement investigative and preparatory activity in their respective area of operations related to the Presidential transition of Power, and enable sharing of national trends.

(U//LES) As of 19 January, the FBI had received 643 survey responses to the following questions:


