

#### JURISDICTION:

The Department of Public Safety, Investigation Division (DPS-ID) will be assisting the Lincoln County Sheriff's Office during the duration of this event in Lincoln County. The Lincoln County Sheriff's Office will be taking the lead law enforcement role for the duration of this event. DPS-ID will provide the assistance needed to the Lincoln County Sheriff's Office to ensure the overall success and a safe outcome during this event. All assisting officers and agencies will be assigned to a Lincoln County Sheriff's Deputy attached to a predesignated patrol unit assigned to a specific area.

#### LOCATION

#### Area 51(Groom Lake)

Area 51 is the common name of a highly classified United States Air Force (USAF) facility located within the Nevada National Security Site (NNSS) or the Nevada Test Site (NTS). Officially, the facility is called Homey Airport (KXTA) or Groom Lake, named after the salt flat situated next to its airfield. Although details of the facility's operations are not publicly known, the USAF says it is an open training range, and it most likely supports the development and testing of experimental aircraft and weapons systems, based on historical evidence. Area 51 is highly secured with layered intruder countermeasures that have an increasing level of human and automated deterrence including automated deadly force countermeasures.



#### **Rachel Nevada:**

#### **Rachel Demographics**

Rachel, Nevada in Lincoln County is the unincorporated township where the only business in the area, the Little A'Le'Inn is located. Rachel is the closest populated area to the entrance of Groom Lake. Rachel has full time population of 54 residents.




#### Climate

The average September temperatures in Rachel are 93° average high and 59° average low; however September temperatures in Rachel can often exceed 97° and be below freezing at night. On average Rachel receives 0.4 inches of rain in September, however, flash flooding is possible.

#### BACKGROUND

In June of 2019, Comedian Matty Roberts created a Facebook page to advertise a planned social media event titled "Storm Area 51, They Can't Stop All of US." The event was initially started as a joke. The event description states "We will all meet up at the Area 51 Alien Center tourist attraction and coordinate our entry. If we Naruto run, we can move faster than their bullets. Let's see them aliens." A "Naruto run" is a reference to a Japanese cartoon character.

The Website went viral and has over 2 million followers. Currently 2 million people have indicated that they are "going" with another 1.4 million people interested. The event is scheduled for Friday, September 20. Area 51 is the highly classified United States Air Force (USAF) facility within the NNSS. Officially, the facility is called Homey Airport (KXTA) or Groom Lake.

On July 22, 2019, the Federal Bureau of Investigation (FBI) held a meeting to discuss the Facebook Page, Storm Area 51. The attendants were local law enforcement, FBI, Nevada DPS, Bureau of Land Management (BLM) and various people/analysis from the Department of Defense, NNSS and base security.

On August 1, 2019, the Division of Emergency Management (DEM) coordinated a jurisdiction and stakeholders conference call to determine how the state can assist Lincoln and Nye Counties in planning efforts for the September 20<sup>th</sup> event. Authorities from each county have expressed serious concern about the potential of an overwhelming number of participants. This event has the potential to exceed local capabilities.

The communities of Rachel in Lincoln County and Armargosa Valley in Nye County are expected to be the areas most impacted by this event. These two towns are extremely remote and have very few resources. If more than 1,000 people show up to the event, this will exceed the resource capabilities of each county. Businesses at each of the venue sites have applied for special event permits featuring live music. The Little A'Le'Inn in Rachel is working with 3-4 families to open approximately 30-40 acres of land for the event. A business in Las Vegas, Area 15 <a href="https://area15.com/">https://area15.com/</a>, is hosting a live stream of the event. Flyers in Las Vegas have been hoax advertising "Area 51 Music Festival for Newly Liberated Aliens" scheduled for September 21-23, 2019. All hotels and campgrounds in the area have been booked during this timeframe.

#### The Following information was provided as a result of a meeting held in Alamo Nevada on August 2, 2019:

These notes consist of items that were discussed during the meeting Alamo Meeting on August 1, 2019 and the NV NTAC Meeting in Carson City on August 2, 2019. Notes from the NV NTAC meeting will start with "NV NTAC" information without that notice was provided by the Alamo Meeting.

#### **Current Security Concerns:**

People are already conducting surveillance and posting videos on social media sites in anticipation A group of YouTubers have tried to put a tracker on the Area 51 bus. They are currently trying to identify the bus occupants, identify their cars, following people home to obtain their name and addresses.

The Area 51 bus will be moving to a secure location inside the airport. This change should happen quickly and is likely to be permanent. There have already been 3 search and rescue events – all were related to individuals scouting the area Have already seen an increase in traffic in the area.

Two special event permits in Lincoln County have been requested – Lincoln County is looking at making security and sanitation the responsibility of the permit holder.

#### COMMUNICATIONS

Both Armargosa Valley and Rachel are considered dead zones for cell communications. In Lincoln County during the 2015 flash floods, traffic was backed up from Ely to Las Vegas due to washouts and detours. Cell service in the communities of Caliente, Pioche, Panaca and Alamo were unavailable due to the amount of calls overwhelming the system during this event. We can expect similar outages in both of these areas.

We will be using a combination of radios, cell phones, In Reach Texting Units and satellite phones. Communications is a challenge in remote areas of Nevada.

The Nevada Department of Emergency Management has been working with the Nevada Army National Guard to assist in the area of communications. Once a plan has been completed, a full communication plan will be attached to this operation plan

#### **CBRNE RESPONSE PROTOCOLS:**

Responses will be determined based on threat assessment and totality of circumstances:

- After arrival on scene, conduct 25'/100' search of initial safe area (situational dependent). Begin gathering initial
  intelligence of item/substance...possible threats, possible targets, critical infrastructures, hazardous conditions...etc.
- Threat assessment (not all-inclusive):
  - 1. When did the item show up?
  - 2. How long has it been there? (Surveillance video? Witnesses?)
  - 3. Did anyone see the person that left the item?
  - 4. Where is it placed? (In front of any strip hotel or in an
  - abandoned dirt lot? Entry way or exits? Crowded waiting area?)
  - 5. How is it placed? (Does it look like it was deliberately hidden
  - in a populated area?)
  - 6. Have there been any recent threats?
  - 7. What does the item look like? (Wires, switches, modifications,
  - sounds, exceedingly heavy looking, any other suspicious indicators?)
  - 8. If you feel the item is clear based on the totality of the
  - circumstances? Did an EDD (Explosive Detection Dog) alert on the item?
  - 9. \*\* People and Property are the most valued targets by terrorists \*\*
  - 10. Are there any victims?
  - 10. Is the item suspicious, abandoned, or temporarily unattended?
  - **C-chemical**: Gas/Vapor- possibly contaminated areas/items will be monitored using the Multi-Rae 5 gas PID. The contingency test if these monitors are not serviceable will be the M256 kit or the MX908 if the gas/vapor is believed to be a chemical warfare agent.
    - Liquid/powder/solid-these substances will be tested using FTIR/RAMAN technologies based on sample. Both will be used when needed to confirm identification using multiple technologies. RAMAN will be used when possible for identification through plastic and glass containers thus limiting contact with possible contamination.
  - **B-biological**: As with all agents, contamination avoidance is an important part of sample identification. Based on the amount of possible agent; minimization of agent contact should be considered. Multiple tests should be run simultaneously there by contacting the possible agent only once. Items believed to be biological will be tested using the 20/20 Bio-Check kit for protein and Ph, the Prime Alert for the eleven CDC-identified bacteria of concern. If the agent is believed to be Anthrax, Botulinum toxin or Ricin, SEB, Yersinia pestis (plague) it will be confirmed with an ADVNT Pro Strip hand-held assay.
  - **R-radiological/N-nuclear**: All types of radiation are of concern and similar to chemicals in that contamination avoidance is an important part when identifying and isolating the source. Four types of radiation that can be detected with the unit's equipment are Alpha particles, Beta particles, Gamma rays and Neutrons. The types of radiation sources that will be most easily detected and thought to be the types used for constructing RDDs and INDs are Gamma and Neutrons

emitting sources. Reactive and proactive radiological surveys can be conducted using either overt or covert techniques. Reactive surveys are used for lost sources and when requested by others to locate and identify a particular threat. In the reactive survey once a alarm is indicated by the use of a Personal Radiation detector (Thermo Rad-eye); the source or the general area of the source must be located. If this cannot be accomplished with the PRD, The FH40 with large sodium iodide canister (natural background rejection) will be used. Upon location of the source, a RIID will be used to determine the isotope and its classification. The classifications will be determined as: medical, industrial or special nuclear material upon completion of this: a survey and inspection of the immediate surroundings will be conducted to determine if the located source was being used to mask another. If this is a post-dissemination situation and radiation is present a survey must be conducted to determine the area of contamination. Proactive surveys can also be done at known locations and venues using Portals, backpacks (Thermo Pack eye) and PRDs.

- E-explosive: Based on the totality of circumstances and the intelligence received by public safety personnel, witnesses, victims or suspects the item will either be identified as unattended, suspicious or suspect. If the item is thought to be unattended an initial assessment will be conducted. This will include but not be limited to: explosive detector dogs, explosive trace detection, visual inspection and hand entry. If the item is thought to be an IED or VBIED, as identified by public safety personnel, witnesses, victims or suspects; the mitigation will be turned over to certified bomb technicians.
- **Decontamination:** If it is required for operators to don personal protective equipment and make entry into an area that is believed to be contaminated, a decontamination corridor will be established. Medical monitoring will be conducted on entry team members, decontamination team members and rapid intervention team members per OSHA guidelines. The decontaminants and scale of the line will be determined based on the incident and potential contaminant. No one will make entry into the hot zone until the decontamination site is established and certified by the decontamination team leader. Upon completion of decontamination operations, all entry team members and any other personnel that wore personal protective equipment will be medically screened per OSHA guidelines.
- **Recovery:** Upon completion of a CBRNE call, any consumable items used will be replaced or restocked. Any equipment that was used will recharged and ops-checked. All items of evidence will be impounded and reports completed as soon as possible following any response or call out. Impounded evidence will be transported as soon as possible to any laboratories for confirmation testing if required.

#### **Pre-Event Sweep:**

Any areas that will primarily be used by first responders for any reason, any area designated as a command post or critical infrastructure within proximity to the event. Areas will be checked for CBRNE threats before any personnel begin arriving or as soon as reasonably achievable. Preferred that those areas then remain secured by on-scene personnel for the duration of the event.

All field-testing equipment is "presumptive" which means we cannot officially identify them as WMD. We can and will however, use the information to pass along for mitigation tactics and medical treatments for anyone that might be affected. Unknown biological powders will be collected and over-packed for further testing at the Southern Nevada Public Health Lab, a member of the CDC Laboratory Response Network, authorized to conduct confirmatory testing for Biological WMD. If powders are determined not to be biological in nature, they will be over-packed and submitted to the LVMPD forensics lab for confirmatory chemical identification.

Radiological alarms by themselves do not create probable cause for action. Additional information is needed but the alarm can point in a particular direction to pay closer attention to an individual, vehicle, items or location.


#### **DETENTION FACILITIES**

Lincoln County Sheriff's Office Detention Facility is located in Pioche Nevada, approximately 107 miles away. The Facility current available space, can house approximately 50 inmates before meeting full capacity.

The Lincoln County Sheriff's Office will establish a temporary booking location away from the event at the Hiko Fire Station located at Highway 318 and MacKintosh Blvd, Hiko Nevada. All misdemeanor/Gross Misdemeanor arrests will be booked and released at this location on a case by case pending the severity of the Gross Misdemeanor. All felony arrests will be transported to this location, booked and/or transported to the Lincoln County Sheriff's Office in Pioche, Nevada located at for booking and/or holding.

Air Force security will be establishing Temp Holding Facilities at each gate. These holding facilities can hold up to 150 inmates temporally. Once in custody by the Air Force, the inmates will be transferred to a LEO for booking and/or release.

The Nevada Department of Correction will provide four transport vans and 8 Correctional Officers to conduct all transports to and from the Detention Facilities established within the area of the event. They will assist in the transport to both the temporary booking location at Hiko as well as the Lincoln County Sheriff's Office for bookings.



#### **MEDICAL PLAN**

Rachel has no medical or Emergency Medical Service (EMS) infrastructure in its vicinity. The nearest EMS is the Alamo Volunteer Ambulance which has 2 Intermediate Life Support (ILS) ambulances 51 miles away. The nearest hospital is the Grover C. Dils Medical Center in Caliente, NV, 82 miles away. This hospital is very limited in capability with an 8 inpatient bed limit and a 6 bed emergency room (ER). The closest Trauma Center is the University Medical Center of Southern Nevada (UMC) which is 148 miles from Rachel. It is a1.2 hour helicopter ambulance ride to the trauma center.

Armargosa Valley has no hospitals and a small volunteer 2 ILS ambulance service. The closest hospital is the Desert View Medical Center in Pahrump, Nevada, which is 44.6 miles from Armargosa Valley. The Desert View Medical Center has a 25 inpatient medical surge capability with an 11 bed emergency room (ER). Desert View has 2 Advanced Life Support (ALS) helicopters. The closest Trauma Center is UMC which is 88 miles away or 44 minutes by helicopter.

Grover C Dils, Medical Center located in Caliente, NV will be open and staffed as normally scheduled. The Alamo Clinic located at 33 Joshua Tree St, Alamo, NV will be open for the duration of the event and will be staffed with one (1) Medical Provider and two (2) Medical Nurses.

Guardian EMT services are planned to have approximately six (6) ambulance vehicles for the event and will be at the direction of the Lincoln County Medical Directors/Medical Staff to determine the medical needs of each patient in a case by case basis.

All emergencies should initially be addressed by trained first responders if available, with medical in route. Once EMS is on scene, they will assume control of the situation. Available Law Enforcement will assist will scene control until the incident has been resolved.

#### Environmental Exposure and hazards

Temperatures may exceed 100° and be lower than freezing in the high desert. Estimates suggest approximately 60% of participants will not be prepared for desert extremes. People will lack water, appropriate clothing and shelter.

<u>Potential missions may include</u>: Cooling stations, lifesaving hydration and air medevac for heat stroke patients. Bottled water may be needed to be trucked in.

#### **Civil Unrest**

The originally stated intent of this event is to break the law by rushing onto restricted areas confronting legal efforts to deny entry onto classified national security sites. A certain portion of the participants may be armed and could expect armed conflict. There may be armed counter protesters or rival gangs which could create a law enforcement incident. The county resources for law enforcement will be quickly exceeded even if a minimal participant response is experienced.

<u>Potential Missions may include</u>: Additional law enforcement via mutual aid and the deployment of additional law enforcement agencies. A deployment of Nevada National Guard Military Police and troops may be needed, but would be highly political and controversial. The NHP and Nevada Department of Transportation (NDOT) may have to block roads and actively deny entry to sensitive areas and assist with traffic control. Large scale arrests may occur which could prompt the possibility of needing corrections busses and temporary holding facilities.

#### Flash Floods

Flash floods are common in the area in the late summer/early fall. Some participants may be caught in flash flood events or be isolated due to flash floods requiring rescue.

Potential Missions may include: Search and Rescue (SAR) helicopters and teams along with swift water rescue teams.

#### Wildfire

By the time of this event, Nevada will be at the peak of its fire season. Temperatures, range and fuels conditions will be ideal for major wildfires. This fact and the fact that two of the largest fireworks sales establishments are adjacent or near the two likely gathering points, combined with the report of "rave parties" and bon fires will create the likelihood of a wildfire requiring rescue, fire suppression and incident management considerations.

Potential Missions may include: Staging initial attack firefighting equipment and crews at anticipated congregation sites.

#### Mass Casualties


The potential for armed conflict and naturally hazardous conditions increases the possibility of mass casualties which likely will exceed the limited capabilities of the two involved counties.

<u>Potential Missions may include</u>: Establishing a casualty collection and triage site; bringing in Mass Casualty Incident (MCI) trailers from other counties; Bringing in a strike team of ambulances; staging multiple medevac helicopters at each venue; and activating the medical element of the National Guard Chemical, Biological, Radiological and high yield Explosive Enhanced Response Force Package (CERF – P).

#### Terrorism

There is a potential for domestic and foreign terrorist groups to utilize this event to test the security of sensitive national security sites by infiltrating the groups planning to storm the facility.

Potential Missions may include: Activation of federal Emergency Support Function (ESF)-13 Public Safety. This is the Federal Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF) and they support federal partners only.



# The First Amendment


 Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the Government for a redress

of grievances.





# **PS** Policy 426



 The Nevada Department of Public Safety respects the rights of people to peaceably assemble. It is the policy of this Department not to unreasonably interfere with, harass, intimidate or discriminate against persons engaged in the lawful exercise of their rights, while also preserving the peace, protecting life and preventing the destruction of property.

 Individuals or groups present on the public way, such as public facilities, streets or walkways, generally have the right to assemble, rally, demonstrate, protest or otherwise express their views and opinions through varying forms of communication, including the distribution of printed matter.



 These rights may be limited by laws or ordinances regulating such matters as the obstruction of individual or vehicle access or egress, trespass, noise, picketing, distribution of handbills and leafleting, and loitering.

### Officers shall not take action or fail to take action based on the opinions being expressed.



- Participant behavior during a demonstration or other public assembly can vary. This may include, but is not limited to:
- (a) Lawful, constitutionally protected actions and speech
- (b) Civil disobedience (typically involving minor criminal acts)
- (c) Rioting



 All of these behaviors may be present during the same event. Therefore, it is imperative that law enforcement actions are measured and appropriate for the behaviors officers may encounter.

 This is particularly critical if force is being used. Adaptable strategies and tactics are essential. The purpose of a law enforcement presence at the scene of public assemblies and demonstrations should be to preserve the peace, to protect life and prevent the destruction of property.

### Officers Should Not:

(a) Engage in assembly or demonstration-related discussion with participants.
(b) Harass, confront or intimidate participants.
(c) Seize the cameras, cell phones or materials of participants or observers unless an officer is placing a person under lawful arrest.



- When responding to an unplanned or spontaneous public gathering, the first responding officer should conduct an assessment of conditions, including, but not limited to, the following:
- (a) Location.
- (b) Number of participants.
- (c) Apparent purpose of the event.
- (d) Leadership (whether it is apparent and/or whether it is effective).
- (e) Any initial indicators of unlawful or disruptive activity.
- (f) Indicators that lawful use of public facilities, streets or walkways will be impacted.
- (g) Ability and/or need to continue monitoring the incident.

- Initial assessment information should be promptly communicated to DPS Communications Bureau, and the assignment of a supervisor should be requested.
- Additional resources should be requested as appropriate.

 The responding supervisor shall assume command of the incident until command is expressly assumed by another, and the assumption of command is communicated to the involved members.

 A clearly defined command structure that is consistent with the Incident Command System (ICS) should be established as resources are deployed.



 For planned events, comprehensive, incidentspecific operational plans should be developed.

The ICS should be considered for such events

 An operational planning team with responsibility for event planning and management should be established.

 The planning team should work directly with the Nevada Threat Analysis Center (NTAC) for guidance, planning, information sharing and proper dissemination.

The planning team should develop an operational plan for the event.

- The operational plan will minimally provide for the following:
- (a) Command assignments, chain of command structure, roles and responsibilities.
- (b) Staffing and resource allocation.
- (c) Management of criminal investigations.

- (d) Designation of uniform of the day and related safety equipment (e.g., helmets, shields).
- (e) Deployment of specialized resources.
- (f) Event communications and interoperability in a multijurisdictional event.

- (g) Liaison with demonstration leaders and external agencies.
- (h) Liaison with State government and legal staff.
- (i) Media relations.
- (j) Logistics: food, fuel, replacement equipment, duty hours, relief and transportation.


- (k) Traffic management plans.
- (I) First aid and emergency medical service provider availability.
- (m) Prisoner transport and detention.
- (n) Review of policies regarding public assemblies and use of force in crowd control.

- (o) Parameters for declaring an unlawful assembly.
- (p) Arrest protocol, including management of mass arrests.
- (q) Protocol for recording information flow and decisions.

 (r) Rules of engagement, including rules of conduct, protocols for field force extraction and arrests, and any authorization required for the use of force.

(s) Protocol for handling complaints during the event.

 Line level Sworn Personnel should be briefed before the event regarding specific assignments, uniform of the day, communications, and when to report for duty.





   Department policy and applicable law.

- Handcuffing and Restraints, Policy 304
- Control Devices and Techniques, Policy 305
- Electronic Control Device Guidelines, Policy 306

 Individuals refusing to comply with lawful orders (e.g., nonviolent refusal to disperse) should be given a clear verbal warning and a reasonable opportunity to comply.

 If an individual refuses to comply with lawful orders, the Incident Commander shall evaluate the type of resistance and adopt a reasonable response in order to accomplish the law enforcement mission (such as dispersal or arrest of those acting in violation of the law).

 Control devices and electronic control devices should be considered only when the participants' conduct reasonably appears to present the potential to harm officers, themselves or others, or will result in substantial property loss or damage.

 Force or control devices, including oleoresin capsaicin (OC), should be directed toward individuals and not toward groups or crowds, unless specific individuals cannot reasonably be targeted due to extreme circumstances, such as a riotous crowd.



 Any use of force by a member of this Department shall be documented promptly, completely and accurately in an appropriate report. The type of report required may depend on the nature of the incident.

### Arrests

- The Nevada Department of Public Safety should respond to unlawful behavior in a manner that is consistent with the operational plan. If practicable, warnings or advisements should be communicated prior to arrest.
- Mass arrests should be employed only when alternate tactics and strategies have been, or reasonably appear likely to be, unsuccessful. Mass arrests shall only be undertaken upon the order of the Incident Commander or the authorized designee. There must be probable cause for each arrest.

### Arrests

If employed, mass arrest protocols should fully integrate:

(a) Reasonable measures to address the safety of officers and arrestees.

(b) Dedicated arrest, booking and report writing teams.

(c) Timely access to medical care.

(d) Timely access to legal resources.

(e) Timely processing of arrestees.

(f) Full accountability for arrestees and evidence.

(g) Coordination and cooperation with the prosecuting authority, jail and courts.

# Social Media Event – Storm Area 51

#### (U) Overview

(U//FOUO) On 16 July 2019, the Nevada Threat Analysis Center in Carson City, and the Southern Nevada Counter Terrorism Center in Las Vegas were advised of a planned social media event titled "Storm Area 51, They Can't Stop All of US".<sup>1</sup> The event was initially started as a joke. The event description states "We will all meet up at the Area 51 Alien Center tourist attraction and coordinate our entry. If we Naruto run, we can move faster than their bullets. Let's see them aliens." A "Naruto run" is a reference to a Japanese cartoon character. The event is currently hosted by: "Shitposting cause im in shambles", "SmyleeKun", and The Hidden Sound. They also maintain a website to sell merchandise at www.stormarea51.us. The initial event was scheduled to run from 0300-0600 hours on Friday, 20 September 2019.

(U//FOUO) SNCTC and the NTAC will be sending out Situation Reports (SitReps), as warranted, regarding this event to affected partners. New information will be highlighted in red.

## (U) 23 August Update

- (U) Permit Approvals in Lincoln County
  - According to open source 2 permits in Lincoln County were granted on Monday, 19 Aug 2019:
    - o Alienstock at the Little A'le'Inn in Rachel
      - This will be a music festival held 19-22 September.
      - URL for the event is: <u>https://alienstockfestival.com/</u>
    - UFOlogy Expo
      - This will consist of bands and food trucks at the Alien Research Center and will be held 20-21 September.
  - The number of attendees at the above events is currently unknown.
  - Permits can be revoked if the organizers do not have everything lined up by 3 September.<sup>2</sup>
  - The permit requestor is responsible for trash, security, porta potties, etc.
  - Immediate needs for event planning for all events include:
    - o Housing and feeding first responders
    - o Radios/Communications
    - o Fuel trucks
- (U) Permit Denials in Nye County
  - On 20 Aug, the Nye County Commission denied an application for a festival permit. The festival "Peacestock 51" was planned to be held in Armargosa Valley.<sup>3</sup>

# Social Media Event – Storm Area 51

- (U) Emergency Declaration
  - On 21 August, Lincoln County signed a declaration of emergency as a preemptive measure in anticipation of the overwhelming number of visitors. The declaration will help bring LE from neighboring counties and provide funding needed to manage the crowds.<sup>4</sup>
- (U) NV DEM Updates
  - Portable reader board signs will be pre-staged, the exact locations are still TBD.
  - DEM is looking into the possibility of extending Freeway Patrol's AOR for the weekend of the events.
  - They plan to add fuel at the maintenance stations for NHP and NDOT vehicles.
  - Contractors will be hired to conduct post-event cleanup (including biohazards).
  - State parks will have extra rangers on site.
  - Health and Human Services advised they have a 15-bed mobile hospital unit that can be sent to Lincoln County if requested.
  - All residents of Rachel, NV and the Armargosa Valley have been advised to be prepared to be stuck without any assistance for several days. It has also been recommended that they have at least seven days of food, water, and necessities on hand, just in case.
  - NHP is providing 24-hour patrols to the affected areas and will implement road closures as a necessary last resort.
- (U) Lincoln County Updates
  - The county is working on an Incident Action Plan (IAP).
  - Media is actively involved with the event and making requests.
  - Traffic is still a major concern in addition to the availability of fuel and commodities (food/water/etc).
  - The current number of visitors at the Alien Research Center are still high approximately 800-1000 people per day.
- (U) Nye County Updates
  - The county is working on IAP.
  - They are working on medical and transport plans.
  - They are activating Beatty jail for the event.

(U//LES) Nye County officers received a report that an unidentified subject contacted a hotel in Tonopah and asked how far the hotel was from Area 51 and what the rules are regarding carrying a rifle. Nye County Sheriff's Office will be following up on the report. The phone number is a Verizon number with no customer information. A Grand Jury Subpoena on the phone number was submitted. A guardian was opened and closed on the event; however, the Nye County Sheriff's Deputy (who is also a JTTF TFO) has reopened the guardian event and is using it for this investigation.

(U//LES) At least one identified First Amendment Auditor, JP Ambriz<sup>USPER</sup>, has expressed an interest in attending this event. This leaves open the possibility of auditors leaving the Area 51 Event and returning to Las Vegas and disrupting other government operations within our jurisdiction.<sup>5</sup>

(U//LES) Security Updates

- Lincoln County Sheriff's Office has limited resources and cannot handle a large scale event solo. Should a large-scale event occur, they will be requesting assistance from other jurisdictions.<sup>6</sup>
- Test site security officials are taking the event seriously and are taking additional security measures.



#### SITUATION:

Storm Area 51 event is now expected to run from Thursday September 19th to Sunday September 22nd based on open source/social media reviews.

Expected attendance is between 2000-10000 based on best available information

#### Lincoln County

- They are unable to accurately predict number of people who will attend this event. Currently (per recent Lincoln County info on 8/15 conference call) 800-1000 people per day are coming through Rachel. The epicenter of the event is expected to be Little A'le'Inn Hotel in Rachel. All 12 rooms are sold out and they have rented RV spots to media crews from all around the country. Summer temperatures will be a factor, as will the lack of ready access to resources. (94 degrees will be the average high and 59 degrees will be the average low).
- In the beginning social media identified "the Alien Travel Center" in Amargosa Station/Lathrop Wells as the kick off location for the push to enter Area 51 and Google Maps identified the most direct route to Area 51 as the Mercury Highway beginning at Highway 95 and continuing through the NNSS Main Gate and into a restricted government installation or the turn off into NNSS off of Highway 95 at Lathrop Wells, Nevada. The traffic in and around the area has significantly increased and the sales of Alien memorabilia has increased. A significant number of hotels, motel rooms and RV spaces have been reserved during the event time period. In addition, off road clubs and social groups have professed an interest in traveling to the area. The weather is projected to be clear and dry with average temperatures ranging from 95 degrees during the day to a low of 70 degrees at night.

#### The main areas of concern in Lincoln County are:

- Rachel, NV (expected primary area)-, LVMPD TASS-TRV and extra cameras deployed for intelligence and situational awareness for the Unified CP.

#### Nye County

- Parking- Vehicles will be staged in the Hwy 373 Main Staging Area located approximately 2.5 miles from the junction of HWY 373 and HWY 95. A secondary Staging Area will be located on Mercury Highway near the Cattle Guard. The Public Works Department will provide a fuel truck twice a day for refueling and the Amargosa County Yard fuel pumps are approximately five miles from the staging area. Outrider vehicles will be fueled in Beatty, Tonopah, and Blue Jay County and State Yards.
- o Event Details -
  - The objective of the HSST team is to be a QRF upon the request of Lincoln County for instances needing crowd control, ingress/egress/traffic control, active shooter response, or mass casualty event response.
  - The objective of the CT undercover team is to determine the size of the crowd, the intent of the crowd, and determine if additional assets will need to be deployed into the area. The UC team will be assigned Sat phones and will be required to check in with the Command Post at a minimum of every 3 hours.
  - The objective of the CT response team is to investigate any threats or suspicious activity reports relating to the event. The CT response team will remain in the Las Vegas Valley unless deployment to the event is directed by the Command Post.
- Safety measures All officers assigned to the event will be required to have all tactical gear (including gas mask and helmet) along with sufficient food and water for at least a 12-hour shift as there are minimal resources available in the Area of Operations.

#### **OPERATIONAL DETAIL:**

- o Officers will remain on standby and available for deployment from their respective staging areas.
- For large scale incidents, all operations will be run out of the Lincoln County Command Post at Tikaboo Peak (MM21)

 Fuel management will be a concern. For units needing to refuel, all attempts to use the LVMPD-issued gas card at a gas station in Alamo or Rachel should be made. If local supplies are exhausted, the next source will be the fuel set aside for LVMPD by the Lincoln County Sheriff/State Emergency Management. Finally, if those two sources are unavailable, fuel can be obtained from the LVMPD fuel trucks which will be staged at the Pahranagat Middle School in Alamo (151 S Main St, Alamo, NV). - There is Verizon cell phone service in Rachel with limited data. Some Sprint phones will work in roaming mode. Phones will other carriers will not have service. The range of the cell site is limited and ends a few miles outside of town.
- LVMPD EM has contacted Verizon Wireless to order their Cellular on Wheels (COW) to be deployed to Rachel to improve communications-Prioritization under the old GETS account feature \*272 will give bandwidth to emergency phones on Verizon; this tower can handle up to 20,000 phones for text/data, UNLESS someone uses a live-streaming feature and that drops to 1000 people.
- FBI will provide 10 radios and a repeater operated by their personnel to supplement communication
- Officers will be able to the LVMPD radio system in a car-to-car capacity within line-of-sight.
- Team leaders will be issued a satellite phone to fill any communications gaps. LVMPD EM will be providing 6 Satellite phones to external partners/key persons forward deployed for comms between CP locations for decision making.
- National Guard CST are assisting with installing temporary radio repeaters in the area to expand coverage

Nevada Department of Corrections is Forward Deploying a bus and Corrections Officers along with a mobile booking station. NDI will man this as well.

#### (U) Overview

(U//FOUO) On 16 July 2019, the Nevada Threat Analysis Center in Carson City, and the Southern Nevada Counter Terrorism Center in Las Vegas were advised of a planned social media event titled "Storm Area 51, They Can't Stop All of US".<sup>1</sup> The event was initially started as a joke. The event description states "We will all meet up at the Area 51 Alien Center tourist attraction and coordinate our entry. If we Naruto run, we can move faster than their bullets. Let's see them aliens." A "Naruto run" is a reference to a Japanese cartoon character. The event is currently hosted by: "Shitposting cause im in shambles", "SmyleeKun", and The Hidden Sound. They also maintain a website to sell merchandise at www.stormarea51.us. The initial event was scheduled to run from 0300-0600 hours on Friday, 20 September 2019.

(U) The USAF facility commonly known as Area 51 is a highly classified remote detachment of Edwards Air Force Base (AFB), within the Nevada Test and Training Range. According to the Central Intelligence Agency (CIA), the correct names for the facility are Homey Airport (ICAO: KXTA) and Groom Lake, though the name Area 51 was used in a CIA document from the Vietnam War. The facility has also been referred to as Dreamland and Paradise Ranch, among other nicknames.<sup>2</sup>

(U) The special use airspace around the field is referred to as Restricted Area 4808 North (R-4808N). The base's current primary purpose is publicly unknown; however, based on historical evidence, it most likely supports the development and testing of experimental aircraft and weapons systems. The intense secrecy surrounding the base has made it the frequent subject of conspiracy theories and a central component to unidentified flying object (UFO) folklore. Although the base has never been declared a secret base, all research and occurrences in Area 51 are Top Secret/Sensitive Compartmented Information (TS/SCI). On Jun. 25, 2013, following a Freedom of Information Act (FOIA) request filed in 2005, the CIA publicly acknowledged the existence of the base for the first time, declassifying documents detailing the history and purpose of Area 51.<sup>3</sup>

(U) Area 51 is located in the southern portion of Nevada in the western US, 83 miles (134 km) north-northwest of Las Vegas. Situated at its center, on the southern shore of Groom Lake, is a large military airfield. The site was acquired by the USAF in 1955, primarily for the flight testing of the Lockheed U-2 aircraft. The area around Area 51, including the small town of Rachel on the "Extraterrestrial Highway", is a popular tourist destination.<sup>4</sup>

(U//FOUO) SNCTC and the NTAC will be sending out Situation Reports (SitReps), as warranted, regarding the "Storm Area 51" event to affected partners. New information will be highlighted in red.

  - The Alienstock event received a Temporary Mass Gathering Permit from the NV Division of Public and Behavioral Health for 19-22 September. Permit # LI-110-23531. The event has posted a copy on their social media accounts.
    - This was the last permit approval needed to host the event.
    - According to social media, Brock Daily has created an aerial map showing where the parking and campsites are located. SNCTC and NTAC will be monitoring and provide the map when it has been shared.
  - The Alienstock website has a lot of info available. They are also looking for volunteers to help out.
    - Items listed that are not allowed: Fire Poi/staffs, spray cans, backpacks in the main stage area, glass, weapons of any kind, and animals (service animals are allowed).
    - The page also mentions that there will be little-to-no cell service bring cash.
      - Parking and Camping spots are still available, and costs are listed as the following:
        - \$140 for RV parking no hookups
        - \$60 general parking
        - \$130 camping spot with attached parking
        - \$80 camping spot without parking
        - \$1000 media parking
      - Applications for vendors are still being accepted.
  - The permit issued allows for up to 10,000 people.
  - The festival will feature music, food, and other entertainment on a 65-acre lot (a large of portion of which will be slated for parking and camping).
    - Music will include country, rock and roll, and electronic dance music.
    - The Alienstock website indicates that entertainment planning is not yet completed. It states "Maybe a giant water fight; maybe there will be a gigantic volleyball. Who knows?"<sup>5</sup>
    - Organizers will install a portable stage, port-a-potties, portable showers, a water station, a hand washing station and giant trash bins.
    - There will be 100 security on site some armed.<sup>6</sup>
    - 96 media requests have been received (from outlets as far away as Denmark).

  - The declaration of emergency was signed today.
  - Up to 30,000 visitors are expected.<sup>8</sup>
  - Conditional permits require festival and event organizers to provide final plans to the Lincoln County Commission by 3 Sept.<sup>9</sup>

### (U) Nye County Updates

- On 29 Aug 2019, Nye County Commissioners voted 4-0 in favor of the preemptive state of emergency.
   The declaration has a sunset clause dated 22 Sept 2019.
- Officials believe that 1,000 -3,000 people could show up in Amargosa for the event.<sup>10</sup>

### (U) 23 August Update

- (U) Permit Approvals in Lincoln County
  - According to open source 2 permits in Lincoln County were granted on Monday, 19 Aug 2019:
    - Alienstock at the Little A'le'Inn in Rachel
      - This will be a music festival held 19-22 September.
      - URL for the event is: <u>https://alienstockfestival.com/</u>
    - UFOlogy Expo
      - This will consist of bands and food trucks at the Alien Research Center and will be held 20-21 September.
  - The number of attendees at the above events is currently unknown.
  - Permits can be revoked if the organizers do not have everything lined up by 3 September.<sup>11</sup>
  - The permit requestor is responsible for trash, security, porta potties, etc.
  - Immediate needs for event planning for all events include:
    - Housing and feeding first responders
    - Radios/Communications
    - Fuel trucks
- (U) Permit Denials in Nye County
  - On 20 Aug, the Nye County Commission denied an application for a festival permit. The festival "Peacestock 51" was planned to be held in Armargosa Valley.<sup>12</sup>
- (U) Emergency Declaration
  - On 21 August, Lincoln County signed a declaration of emergency as a preemptive measure in anticipation of the overwhelming number of visitors. The declaration will help bring LE from neighboring counties and provide funding needed to manage the crowds.<sup>13</sup>

### (U) NV DEM Updates

- Portable reader board signs will be pre-staged, the exact locations are still TBD.
- DEM is looking into the possibility of extending Freeway Patrol's AOR for the weekend of the events.
- They plan to add fuel at the maintenance stations for NHP and NDOT vehicles.
- Contractors will be hired to conduct post-event cleanup (including biohazards).
- State parks will have extra rangers on site.
- Health and Human Services advised they have a 15-bed mobile hospital unit that can be sent to Lincoln County if requested.
- All residents of Rachel, NV and the Armargosa Valley have been advised to be prepared to be stuck without any assistance for several days. It has also been recommended that they have at least seven days of food, water, and necessities on hand, just in case.

- Media is actively involved with the event and making requests.
- Traffic is still a major concern in addition to the availability of fuel and commodities (food/water/etc).
- The current number of visitors at the Alien Research Center are still high approximately 800-1000 people per day.
- (U) Nye County Updates
  - The county is working on IAP.
  - They are working on medical and transport plans.
  - They are activating Beatty jail for the event.
  - The have procured tow trucks from Pahrump.
  - The county advised immediate needs include assistance with road barricades.

### (U) Clark County Updates

### <u>LVMPD</u>

- LVMPD will be providing a contingency team (quick reaction force (QRF) team).
- The command post (CP) will be at mile marker 21.
- The Lt. assigned to the CP will have a Sat-phone, but no computer access.
  - Metro will stage fuel tanks in the area.

### (U//FOUO) Traffic

#### (U) 30 July Update

(U//FOUO) The numbers are currently at 2 million attending and 1.4 million interested.

(U//LES) Nye County officers received a report that an unidentified subject contacted a hotel in Tonopah and asked how far the hotel was from Area 51 and what the rules are regarding carrying a rifle. Nye County Sheriff's Office will be following up on the report. The phone number is a Verizon number with no customer information. A Grand Jury Subpoena on the phone number was submitted. A guardian was opened and closed on the event; however, the Nye County Sheriff's Deputy (who is also a JTTF TFO) has reopened the guardian event and is using it for this investigation.

(U//LES) At least one identified First Amendment Auditor, JP Ambriz<sup>USPER</sup>, has expressed an interest in attending this event. This leaves open the possibility of auditors leaving the Area 51 Event and returning to Las Vegas and disrupting other government operations within our jurisdiction.<sup>14</sup>

#### (U//LES) Security Updates

- Lincoln County Sheriff's Office has limited resources and cannot handle a large scale event solo. Should a large-scale event occur, they will be requesting assistance from other jurisdictions.<sup>15</sup>
- Test site security officials are taking the event seriously and are taking additional security measures.

#### (U//FOUO) Hotels

- Per Nye County Hotels in Beatty and Amargosa are full
- Per Nye County hotels in Pahrump still have some vacancies but are not fully booked yet
- Per Nye county Tonopah has only had a handful of calls and still has vacancies
- Per Lincoln County on 16 July one hotel in Alamo only had 4 people booked, but they were fielding approx. 40 calls a day regarding reservations for 20 Sept 2019

### (U//FOUO) Transportation

• Per TSA: "we do not have any information supporting a higher than expected passenger volume. The airlines have a static number of seats and that fits into what we are projecting for September. We are experiencing about a 5% growth YoY. We are projecting 457,250 passengers for the week of September 15th and specifically 65,368 on Friday September 20th"

The event is likely a furtherance of the Area 51 Desert Concert event hosted by Ja Rule/Bill McFarland planning a music event in the desert (similar to the Fire Island music event that failed).



(U//FOUO) Next Steps

- Obtain maps of entry locations (Received BLM maps)
- Reach out to Creech and Nellis Air Force Bases to obtain Points of Contacts for information sharing (Completed 7/31)
- Reach out to BLM to obtain additional information (Completed 8/1).

### (U) Suspicious Activity Reporting

(U//FOUO) SNCTC encourages reporting of all suspicious activity. SNCTC encourages private sector, security, and law enforcement partners to remain vigilant. SNCTC faces an increased challenge in detecting terrorist plots underway by individuals or small groups acting quickly and independently, or with only tenuous ties to terrorist organizations. Preoperational indicators are likely to be difficult to detect. State, local, tribal, and private sector partners play a critical role in identifying and reporting suspicious activities and raising the awareness of counterterrorism partners.<sup>17</sup>

#### (U) Overview

(U//FOUO) On 16 July 2019, the Nevada Threat Analysis Center in Carson City, and the Southern Nevada Counter Terrorism Center in Las Vegas were advised of a planned social media event titled "Storm Area 51, They Can't Stop All of US".<sup>1</sup> The event was initially started as a joke. The event description states "We will all meet up at the Area 51 Alien Center tourist attraction and coordinate our entry. If we Naruto run, we can move faster than their bullets. Let's see them aliens." A "Naruto run" is a reference to a Japanese cartoon character. The event is currently hosted by: "Shitposting cause im in shambles", "SmyleeKun", and The Hidden Sound. They also maintain a website to sell merchandise at www.stormarea51.us. The initial event was scheduled to run from 0300-0600 hours on Friday, 20 September 2019.

(U) The USAF facility commonly known as Area 51 is a highly classified remote detachment of Edwards Air Force Base (AFB), within the Nevada Test and Training Range. According to the Central Intelligence Agency (CIA), the correct names for the facility are Homey Airport (ICAO: KXTA) and Groom Lake, though the name Area 51 was used in a CIA document from the Vietnam War. The facility has also been referred to as Dreamland and Paradise Ranch, among other nicknames.<sup>2</sup>

(U) The special use airspace around the field is referred to as Restricted Area 4808 North (R-4808N). The base's current primary purpose is publicly unknown; however, based on historical evidence, it most likely supports the development and testing of experimental aircraft and weapons systems. The intense secrecy surrounding the base has made it the frequent subject of conspiracy theories and a central component to unidentified flying object (UFO) folklore. Although the base has never been declared a secret base, all research and occurrences in Area 51 are Top Secret/Sensitive Compartmented Information (TS/SCI). On Jun. 25, 2013, following a Freedom of Information Act (FOIA) request filed in 2005, the CIA publicly acknowledged the existence of the base for the first time, declassifying documents detailing the history and purpose of Area 51.<sup>3</sup>

(U) Area 51 is located in the southern portion of Nevada in the western US, 83 miles (134 km) north-northwest of Las Vegas. Situated at its center, on the southern shore of Groom Lake, is a large military airfield. The site was acquired by the USAF in 1955, primarily for the flight testing of the Lockheed U-2 aircraft. The area around Area 51, including the small town of Rachel on the "Extraterrestrial Highway", is a popular tourist destination.<sup>4</sup>

(U//FOUO) SNCTC and the NTAC will be sending out Situation Reports (SitReps), as warranted, regarding the "Storm Area 51" event to affected partners. New information will be highlighted in red.

#### (U) 17 September Update

(U//FOUO) Alienstock Event in Rachel, Nevada

- On 12 Sept 2019, a Las Vegas based law firm representing Matty Roberts, sent West (the owner of the Little A'Le'Inn) a cease and desist letter related to the Alienstock event.

- Aircraft banned from flying above the areas south and west of Rachel, Nevada, near the Nevada Test and Training Range – a military training area used by the U.S. Air Force. The bans run from Wednesday, 18 September to Monday, 23 September.<sup>5</sup>

(U//FOUO) Two Dutch Nationals Arrested at Mercury

- On 16 Sept 2019 Govert Sweep and Ties Granzier pleaded guilty to a misdemeanor trespass and illegal parking
- Judge sentenced them to a suspended sentence of 1 year in the county jail they have to serve three days & each pay a \$2,280 fine
- Surrendered approx. \$10,000 worth of computer and camera equipment, to include a drone
- They were arrested attempting to make a YouTube video about Area 51. They both stated they saw the "No Trespassing" signs but they wanted to see the base
- Both plan to return to the Netherlands after being released from jail on Thursday
- Ties Granzier is a very popular YouTuber, with over 748,000 followers and 135 million views. He earns approx. \$22.3k per month. He is the 109th most popular YouTuber out of the Netherlands and 22,115th worldwide. He earns just under \$4,000 per video posted.

Generally, state and local authorities adequately support these events; however, the significance of these events requires national situational awareness and, depending on the jurisdiction, may require limited direct support from specific federal agencies. In order to ensure national situational awareness, an Integrated Federal Support Plan may be developed."<sup>6</sup>

(U//FOUO) Since 31 July 2019, there have been at least 52 trespass events on the Nevada National Security Site<sup>USPER</sup> (NNSS) and the Nevada Test and Training Range<sup>USPER</sup> (NTTR). 19 of these events were at the Mercury Gate, officially referred to as Gate 100. - The Alienstock website has a lot of info available. They are also looking for volunteers to help out.
  - Items listed that are not allowed: Fire Poi/staffs, spray cans, backpacks in the main stage area, glass, weapons of any kind, and animals (service animals are allowed).
  - The page also mentions that there will be little-to-no cell service bring cash.
  - Parking and Camping spots are still available, and costs are listed as the following:
    - \$140 for RV parking no hookups
    - \$60 general parking
    - \$130 camping spot with attached parking
    - \$80 camping spot without parking
    - \$1000 media parking
  - Applications for vendors are still being accepted.
- The permit issued allows for up to 10,000 people.
- The festival will feature music, food, and other entertainment on a 65-acre lot (a large of portion of which will be slated for parking and camping).
  - Music will include country, rock and roll, and electronic dance music.
  - The Alienstock website indicates that entertainment planning is not yet completed. It states "Maybe a giant water fight; maybe there will be a gigantic volleyball. Who knows?"<sup>8</sup>
  - Organizers will install a portable stage, port-a-potties, portable showers, a water station, a hand washing station and giant trash bins.
  - There will be 100 security on site some armed.<sup>9</sup>
  - 96 media requests have been received (from outlets as far away as Denmark).

  - The event at the Alien Research Center is called, "Storm Area 51 Basecamp."
  - "Experience is inspired by the cultural movement to bring greater transparency around what many believe to be decade of government secrecy surrounding alien technology."<sup>10</sup>

  - Jeremy Corbell (creator of the Netflix documentary Bob Lazar: Area 51 & Flying Saucers) will be showing his films and curating the speaker lineup.

- Immediate needs for event planning for all events include:

- (U) Permit Denials in Nye County
  - On 20 Aug, the Nye County Commission denied an application for a festival permit. The festival "Peacestock 51" was planned to be held in Armargosa Valley.<sup>15</sup>
- (U) Emergency Declaration
  - On 21 August, Lincoln County signed a declaration of emergency as a preemptive measure in anticipation of the overwhelming number of visitors. The declaration will help bring LE from neighboring counties and provide funding needed to manage the crowds.<sup>16</sup>
- (U) NV DEM Updates
  - Portable reader board signs will be pre-staged, the exact locations are still TBD.
  - DEM is looking into the possibility of extending Freeway Patrol's AOR for the weekend of the events.
  - They plan to add fuel at the maintenance stations for NHP and NDOT vehicles.
  - Contractors will be hired to conduct post-event cleanup (including biohazards).
  - State parks will have extra rangers on site.

- Have already seen an increase in traffic in the area

#### (U//FOUO) Events

- 2 special event permits in Lincoln County have been requested Lincoln county is looking at making security and sanitation the responsibility of the permit holder
  - o Alien Research Center
    - Will be providing a map with a layout
    - Parking will be an issue, very limited space
  - Little A'Le'Inn in Rachel "Raid Rachel"
    - Approx 30-40 Acres of land for special event (3-4 families are working together)
- Area 15 in Las Vegas is hosting a live streaming event (this will be their first ever live event) <u>https://news3lv.com/news/local/future-las-vegas-retail-complex-to-host-storm-area-51-watch-party</u>
- Burning Man is 25 Aug 2 Sept 2019 at Black Rock Desert Nevada
- Life is Beautiful is 20-23 Sept 2019 in Downtown Las Vegas
- The Belize Tourism Board is offering 10 residents of Rachel (which only has 54 residents) an opportunity to spend 19-21 Sept in Belize. The sweepstake covers airfare and lodging. - NV NTAC: Currently booked Thurs Fri and open on Saturdays at local hotels
- There has been a huge request/demand for RV and Motor home spaces

- There will be a separate communication meeting as a number of issues were identified
  - Comms across multiple agencies LE radios are not on the same frequencies
  - Only 1 repeater tower
    - Repeater likely to go down during event due to the number of people attempting to access it
    - The actual repeater is located inside the NTTR
    - BLM is checking to see if they can bring the mobile cell site from Burning Man
    - Lincoln County is reaching out to Verizon to see what services can be offered
    - Satellite phones were suggested
  - Area around Tikaboo is a dead zone

#### (U//FOUO) NV NTAC: Medical

- NV NTAC: There are currently 2 ambulances in Alamo and 4 in Pioche all are operated by volunteers
- NV NTAC: Checking with White Pine, Clark County, Utah and Arizona for assistance with shelter, LE, medical, communications, Fire and Public Information Officers.
- NV DEM is planning on deploying two 4 person teams one for each location. These teams will include Planning, Operations, PIO and Communications.

#### (U//LES) Geographic Areas of Concern

- Rachel event
- Rachel Gate the gate is easily seen and this area is easy to access
- Tikaboo Gate cannot see the guard shack but the peak overlooks part of the facility. Historically this area has the most trespasses
- Alien Research Center event
- Lythrop Wells (takes you into Mercury)
- Lydell Gate (unsure which county this gate is in)
- Cedar Gate (Nye County)
- Stonewall Gate (Nye County)

#### (U//FOUO) Traffic

- Gas will be an issue the local businesses are likely to run out of fuel
- Checking with DoT to obtain a gas tank that will be for First Responder use only
- Only 2 trucks in Lincoln County & they will not operate on dirt roads
- If large crowds, numerous accidents, flat tires, out of gas, etc...issues are expected
- Rancher Medlin does not want people on his property
  - He is going to close his driveway which is the access point to Tikaboo Peak
  - From the roadside to Tikaboo it is a 5 mile hike each way
  - Looking at making the start of Medlin's driveway area a turnaround point
- Fish and Wildlife may be able to set up an emergency road closure after the event starts if there are problematic areas
  - This is a reactive measure
- NDOT is going to look at getting a traffic counter to help determine crowd size if obtained it is unknown where

(U//FOUO) Command posts are being discussed – there will be one, but the location is still TBD

### (U//LES) Trespassing/Holding Cells/Jails

- Lincoln County judge has increased the fine for trespassing from \$500 to \$1000 for this weekend
- Lincoln County Jail is in Pioche (approx. 70 miles from Rachel) so they do not want to transport anything other than felonies or gross
  - Want misdemeanors to be cite and release but released away from the gates
  - NTTR has two holding cells (which are outside the press viewing area)
- Lincoln County has 1 x Jail Bus and 2 x Jail Vans

#### (U//FOUO) Military/NTTR/NNSS

- NTTR has 300 miles of perimeter fence
- Putting up concertina wire around the facility to help dissuade people from trying to enter the facility
  - Security will be patrolling between the concertina wire and the boundary of the facility
- Creech is concerned about Code Pink/NDE hosting a protest outside there gates that overlaps with Area 51 Event
  - There is a social media event references legally protesting government facilities -<u>https://www.facebook.com/events/456195431898184/</u>

#### (U//FOUO) General Concerns

- NV is open carry
- It is open cattle grazing season there are expected to be at least 3000 cattle open grazing. Visitors hitting cattle, impeding cattle/cowboys, or messing with the water supply could result in issues
- The brush is extremely dry right now campfire are currently prohibited, but if someone starts a fire and loses control, it will spread quickly
- NV NTAC: There are two firework stands/sellers in the area
- NV NTAC: Potential for flash floods
- It's hunting season
- If there is a live broadcast and the number to Lincoln County dispatch is shared, it will crash their system
- Tour companies are offering tours (some are calling Janet Airlines to try and reserve a seat)

#### (U) 30 July Update

(U//FOUO) The numbers are currently at 2 million attending and 1.4 million interested.

(U//LES) Nye County officers received a report that an unidentified subject contacted a hotel in Tonopah and asked how far the hotel was from Area 51 and what the rules are regarding carrying a rifle. Nye County Sheriff's Office will be following up on the report. The phone number is a Verizon number with no customer information. A Grand Jury Subpoena on the phone number was submitted. A guardian was opened and closed on the event; however, the Nye County Sheriff's Deputy (who is also a JTTF TFO) has reopened the guardian event and is using it for this investigation.

(U//LES) At least one identified First Amendment Auditor, JP Ambriz<sup>USPER</sup>, has expressed an interest in attending this event. This leaves open the possibility of auditors leaving the Area 51 Event and returning to Las Vegas and disrupting other government operations within our jurisdiction.<sup>17</sup>

(U//LES) Security Updates

- Lincoln County Sheriff's Office has limited resources and cannot handle a large scale event solo. Should a large-scale event occur, they will be requesting assistance from other jurisdictions.<sup>18</sup>
- Test site security officials are taking the event seriously and are taking additional security measures.

### (U//FOUO) Hotels

- Per Nye County Hotels in Beatty and Amargosa are full
- Per Nye County hotels in Pahrump still have some vacancies but are not fully booked yet
- Per Nye county Tonopah has only had a handful of calls and still has vacancies
- Per Lincoln County on 16 July one hotel in Alamo only had 4 people booked, but they were fielding approx. 40 calls a day regarding reservations for 20 Sept 2019

(U//FOUO) Transportation

• Per TSA: "we do not have any information supporting a higher than expected passenger volume. The airlines have a static number of seats and that fits into what we are projecting for September. We are experiencing about a 5% growth YoY. We are projecting 457,250 passengers for the week of September 15th and specifically 65,368 on Friday September 20th"

(U//LES) Related Events

- The owner of the Alien Tourist Center in Rachel, Nevada is anticipating at least 1,000 people will show up. The owner stated that he is planning to an event to include food and live music. His intent is entertain people and provide a distraction from the actual Storm Area 51 event.<sup>19</sup>
- NTAC located a flyer for the "Area 51 Music Festival for Newly Liberated Aliens". Scheduled for 21-23 September. Although this event has been widely shared on social media, it is a hoax. The event is likely a furtherance of the Area 51 Desert Concert event hosted by Ja Rule/Bill McFarland planning a music event in the desert (similar to the Fire Island music event that failed).

### (U) 12 July 2019 Update

(U//FOUO) The event is currently over 1 million going/interested and has started making international news.

(U//FOUO) There are a lot of other events being created for this – a couple of the more plausible events are:

- Storm Area 51 with drones <u>https://www.facebook.com/events/2441980902690366/</u> this event only has 148 going and 256 interested, but this seems a bit more feasible for people to actually attempt, due the capabilities of drones. This event is hosted by Varsity Media <u>https://www.facebook.com/officialVarsityFILMZ/</u>
- Storm Area 51 Show <u>https://www.facebook.com/events/435435523854558/</u> this event only has 65 going and 75 interested – but it is a metal concert and they will allegedly be selling tickets. A show could draw crowds out to the area.

#### (U) Suspicious Activity Reporting

(U//FOUO) SNCTC encourages reporting of all suspicious activity. SNCTC encourages private sector, security, and law enforcement partners to remain vigilant. SNCTC faces an increased challenge in detecting terrorist plots underway by individuals or small groups acting quickly and independently, or with only tenuous ties to terrorist organizations. Preoperational indicators are likely to be difficult to detect. State, local, tribal, and private sector partners play a critical role in identifying and reporting suspicious activities and raising the awareness of counterterrorism partners.<sup>20</sup>
