(U) Key Updates

(U//FOUO) A summary of significant information since the previous SITREP.

- (U//FOUO) Spokane Riverfront Park protest attendees have been encouraged to bring weapons and agitate LE. Following a peaceful march, during closing speeches, organizers plan to agitate crowd and send them into downtown Spokane to riot. Multiple groups (including Antifa, militia groups, BLM, and local Nazis) plan to attend this event.
- (U//FOUO) FBI Seattle is aware of 19 protests taking place in the AOR on 6/7.

(U) Activity Impacting FBI RA Territory

(U) EAST SIDE

Spokane RA - 1400 Riverfront Park Protest:

- (U//FOUO) Reporting indicates protest organizers are keeping their plans for the protest private for OPSEC purposes. They have provided false information, withheld information, and changed plans for the event and route. After the initial march, beginning at Riverfront Park at 1400, the leaders (NFI) are planning to agitate the crowd during closing speeches and then send the agitated crowd out into downtown Spokane to riot.
- (U//FOUO) Encouragement of Criminal Activity, LE Agitation, and OPSEC:
 - o (U//FOUO) Protesters have been coached to instigate confrontations with police to cause arrests. When LE conducts the arrest, protesters plan to physically attempt to disrupt the arrests and thwart any attempted interviews.
 - o (U//FOUO) Protesters are being encouraged to bring weapons to be used against

LE and white supremacists.

- o (U//FOUO) Participants will be actively attempting to ID undercover LE. If identified, the LE officer may be attacked.
- o (U//FOUO) Protesters have been cautioned about taking video or photos of other engaged in criminal activity, because this aids in prosecution of participants.

- (U//FOUO) OCE reports from a now-public chat group that protesters in Seattle are listening to SPD scanners and reporting safe house location/coordination, police movements, and instances when police observe protesters making Molotov cocktails—the chat group would alert the Molotov group they were being observed by police.
- (U//FOUO) Increasing chatter on Twitter concerning the arrests of protesters by Seattle PD, particularly the arrest of Evan Hreha, who claims to have filmed the viral video showing alleged SPD-involved macing a child. Discussion includes rumors of martial law in Seattle. (Analyst note: Color of Law tips to the FO may increase.)
- (U//FOUO) On 6/7 at 0720, a Seattle citizen was doxed by Twitter account @WANaziWatch for allegedly driving his car aggressively through the 6/6 protest multiple times, hitting protesters once. The individual's name, address, and license plate were provided. (Analyst note: This may indicate a trend in which private citizens, as well as LE, are being targeted in doxing efforts.)
- \bullet (U//FOUO) SPD is expecting 2,000 to 3,000 participants in the 1400 Othello Park rally. (NFI)
- (U//FOUO) For the evening of 6/7, SPD has been directed to open the streets around their HQs building and will not be using barricades.
