In re: Freedom of Information Act (FOIA) Request for Travel Records

Dear Mr. Light:

This is the final response to your June 10, 2017 Freedom of Information Act (FOIA) request to the U.S. Coast Guard (USCG) for travel records and correspondence mentioning or referring to Trump properties. This office received your request on June 20, 2017.

We are granting your request under the FOIA, Title 5 U.S.C. § 552, as amended, and DHS' implementing regulations, 6 C.F.R. Chapter I and Part 5. After carefully reviewing the responsive information, we determined that it is appropriate for public release.

Per my July 12, 2017 telephone conversation with you, it is our understanding that you are willing to accept copies of hotel billing statements that are responsive to your request with the personally identifying information (PII) of service members redacted. Additionally, we queried the Government Travel Charge Card electronic data base for transactions involving Trump properties and identified the activities listed on the enclosed listing. Individual member PII has also been redacted from the listing. No other deletions or exemptions have been claimed.

Provisions of the FOIA allow us to recover part of the cost of complying with your request. In this instance, because the cost is below the \$14 minimum, there is no charge.

I trust that this information fully satisfies your request. If you need any further assistance or would like to discuss any aspect of your request, please do not hesitate to contact us (please refer to the FOIA number referenced above).




