## Suspect arrested in University of Chicago gun threat

### Story highlights

- **Jabari Dean, 21, is accused of threatening to kill students and staff at the University of Chicago**
- He purportedly posted online that he planned to kill 16 white male students or staff
- Students, staff told to stay away; dorm residents asked to stay inside

(CNN)A 21-year-old man was arrested Monday, accused of threatening to kill students and staff at the University of Chicago in an apparent attempt to avenge the death of Laquan McDonald, authorities said.

Jabari Dean, 21 was arrested without incident. He is expected to appear in court later in the day.

According to a criminal complaint, Dean posted a threat on social media over the Thanksgiving weekend.

**"This is my only warning. At 10 a.m. on Monday mourning (sic) I am going to the campus quad of the University of Chicago. I will be armed with a M-4 Carbine and 2 Desert Eagles all fully loaded. I will execute approximately (sic) 16 white male students and or staff, which is the same number of time (sic) Mcdonald (sic) was killed.**

**"I then will die killing any number of white policemen that I can in the process. This is not a joke. I am to do my part to rid the world of the white devils. I expect you to do the same," the post read.**

"Mcdonald" appears to refer to Laquan McDonald, 17, who was shot 16 times and killed last year by Officer Jason Van Dyke. A judge Monday set a \$1.5 million bond for the officer, who has been charged with first-degree murder. Van Dyke posted bond later in the day, authorities said.

The shooting occurred in October 2014, but dashcam video of the incident was recently released, sparking outrage and triggering protests.

NAACP President Cornell Brooks was arrested at a demonstration Monday, along with young seminarians. They were later released, according to the NAACP's Twitter page.

## Threat shuts college

Earlier Monday, the University of Illinois at Chicago had said that one of its students had been arrested. The threat led to the closure of the University of Chicago campus.

"We are monitoring this situation closely and are concerned about the impact this has had on our campus and the University of Chicago," Michael Amiridis, chancellor of the University of Illinois at Chicago, said in a statement.

The University of Chicago said Sunday that FBI counterterrorism officials had informed the school of a threat, specifically of a shooting on "the campus quad" at 10 a.m. Monday.

"Based on the FBI's assessment of this threat and recent tragic events at other campuses across the country, we have decided in consultation with federal and local law enforcement officials, to exercise caution by canceling all classes and activities on the Hyde Park campus through midnight on Monday," the school [said in a statement](#).

The school asked students and nonessential staff to stay away from campus. Students in college housing were asked to stay inside.

## Mixed reaction online

The decision was met with some criticism online.

"Talk about complete panic. .. right now any one of us could shut down anyplace we want with a simple phone call!!" Facebook user Charles Friscia posted to the University of Chicago's Facebook article announcing the closing.

But others praised the school's decision to put safety first.

"I am extremely disappointed in the criticism of this decision without any more information than has been provided," Facebook user Elizabeth Harding wrote. "We have absolutely no idea what type of threat or the degree of danger involved. This must have been a credible threat to have involved the FBI and their ensuing recommendation."

Last week, [Western Washington University canceled classes](#) at its main campus after social media posts suggesting the lynching of a black student government leader as well as other offensive posts.

School President Bruce Shepard didn't detail the threats and said there was "no threat to general campus safety," but said a criminal investigation was underway.

Jim Stachowiak specializes in provoking strong reactions.

In the past, he has called for the U.S. military to bomb Mecca. He made a point of standing outside a military recruiting office in Georgia with a rifle in his hands to provide the center with protection, he said, but was also accused of harassment.

Almost a year later, the former police officer and ardent [Donald Trump](#) supporter has put out a "clarion call" for "lone wolf patriots" to join him at the [GOP](#) convention in Cleveland this summer to confront [Black Lives Matter](#) demonstrators.

"I am encouraging patriots and Trump supporters and those that support liberty and freedom to come lawfully armed with lethal and non-lethal weaponry," Stachowiak said in a video posted on his YouTube over the weekend.

Stachowiak has a lengthy criminal history, according to ABC affiliate WJBF. In 2008, while working as a public safety officer at Augusta State University, his certification was revoked after three years following a misconduct investigation, the station reported. Two years later, WJBF noted, Stachowiak was arrested and charged with criminal defamation for stealing a man's picture from a social networking site, posting it elsewhere and labeling the individual a terrorist.

By his own admission, he's been banned from Facebook at least four times.

In his latest video, Stachowiak accused activists with Black Lives Matter - which he refers to as "Black Lies Matter" - of threatening to kill Trump and planning to disrupt the gathering of Republican leadership.

"They have threatened to cause riots in Cleveland and nationwide," Stachowiak said. "It is our sworn duty and obligation for all those like me and many of you who have taken the oath to defend this country against all enemies foreign and domestic."

A spokesman for the Cleveland Police Department told The Washington Post that she had no information about Stachowiak or what sort of precautions the department might take in light of his plans.

Audrey Scagnelli, national press secretary for the Republican committee organizing the convention, offered The Post the following statement when asked about Stachowiak's video.

*"For the past year planners have been working closely with the Secret Service, the FBI, and additional state, local and federal partners to make sure delegates, attendees and residents of the city of Cleveland are safe during the Convention.*

*Law enforcement partners are monitoring and investigating threats and information related to building and implementing a security plan."*

The Southern Poverty Law Center considers Stachowiak a member of the resurgent "Patriot Movement," whose members subscribe to a conspiratorial, anti-government ideology based on

the belief that federal authorities seek to confiscate people's guns, impose martial law and force the United States into a socialistic "New World Order."

Mark Potok of the SPLC called Stachowiak a "loose cannon" who is "not quite in contact with reality," but noted that he should still be considered dangerous.

"People like him make these kinds of statements very frequently and sometimes it leads to real trouble," Potok told The Washington Post. "When you're encouraging an armed confrontation -- even if you're supposedly keeping it legal - you're inviting trouble."

In his latest video, Stachowiak says he's hoping to "spark a revolution," but in the past he told the SPLC that his actions are always defensive in nature.

"I'd rather go to a movie or make payments on a jet ski, but I have to buy ammo," he said in 2010. "I'm concerned about civil unrest, my neighbors going crazy, round-ups, foreign troops, the New World Order."

Despite their anti-government impulses, Potok told The Post that many in the Patriot Movement have rallied around the candidacy of Trump, the presumptive Republican presidential nominee, because of his stances on several issues.

"Unlike the white supremacists that support Trump, the core of their support isn't based on racism, but they certainly are opposed to immigration, very much in favor of the 2nd Amendment and they think that big government is a wicked thing," Potok said. "They're sort of Republican beliefs on steroids. They're nationalists and Trump is certainly a super-nationalist."

When it comes to Black Live Matters supporters, Stachowiak said in his YouTube video that he believed they "want to attack those of us for merely supporting a candidate."

He added: "Let's answer the call, people."

His opinions aren't limited to the Black Lives Matter movement, according to reports. On his Internet radio show, WJBF reported, Stachowiak accused Mohammad of being a child rapist and called Islam a "mental disorder."

Last year, a Muslim woman who identified herself as Hawwa told WJBF she saw Stachowiak standing outside the military recruiting center. He followed her into a nearby store to get her to notice his shirt, she told the station.

"On the front it says, 'Burn the Koran,' " she said. "On the back, it said something really bad about Allah."

The Richmond County Sheriff's Office told the station at the time that Stachowiak had done nothing illegal.



"You don't egg on somebody like that," Hawwa told the station. "Ultimately, you should feel sorry for him."

The FBI deployed at least 10 flights of planes equipped with advanced aerial surveillance technology, including infrared and night-vision cameras, to monitor the Baltimore protests  
<<http://america.aljazeera.com/articles/2015/5/6/fbi-aircraft-secretly-monitored-baltimore-protests.html>> over the death of Freddie Gray earlier this year, according to government documents obtained by the American Civil Liberties Union.

The flights, totaling more than 36 hours and involving at least two planes, occurred over Baltimore from April 29 to May 3, as showed by flight logs provided to the ACLU under the Freedom of Information Act.

The ACLU released the logs to several news organizations on Friday.

Half of the flights carried Baltimore police in addition to FBI officials, and a majority of them occurred at night over Baltimore during several days of civil disorder

## FBI warns Ferguson grand jury decision 'will likely' lead to violence

The FBI is warning law enforcement agencies nationwide that a grand jury's decision on whether a Missouri police officer will face charges for killing Michael Brown, an unarmed 18-year-old, "will likely" lead to attacks on police officers and key infrastructure.

Violence could erupt following the decision whether or not to indict Ferguson Police Officer Darren Wilson, who is white, in the Aug. 9 shooting death of Brown, a black man, and so-called "hacktivists" could also use the opportunity to launch cyber-attacks against authorities and institutions.

"The announcement of the grand jury's decision ... will likely be exploited by some individuals to justify threats and attacks against law enforcement and critical infrastructure," the FBI said in a bulletin issued Friday. "This also poses a threat to those civilians engaged in lawful or otherwise constitutionally protected activities."

There's no indication an announcement by the grand jury is imminent. The St. Louis County prosecutor has said that he expects the grand jury to reach a decision in mid-to-late November.

The FBI bulletin also stressed the "importance of remaining aware of the protections afforded to the all U.S. persons exercising their First Amendment rights of freedom of speech and freedom of assembly."

FBI officials also cited specific tactics that could be utilized by extreme protesters, including violence against state or federal authorities.

"The FBI assesses those infiltrating and exploiting otherwise legitimate public demonstrations with the intent to incite and engage in violence could be armed with bladed weapons or firearms, equipped with tactical gear/gas masks, or bulletproof vests to mitigate law enforcement measures," the bulletin continued.

Missouri Gov. Jay Nixon declared a state of emergency and activated the National Guard Monday in advance of the grand jury decision. Nixon said the National Guard would assist state and local police as needed in the event of civil unrest.

Meanwhile, police officials in Ferguson and other cities across America braced Monday for possible violence in the wake of the decision, one day after hundreds of people took to the streets of St. Louis briefly to block a major intersection to protest the death of Brown.

Dozens of protesters could be seen lying down in the street outside of a movie theater hosting a film festival, pretending to be shot in an action intended to evoke the memory of Brown, according to Reuters.

"This is a mature movement. It is a different movement than it was in August. Then it just had anger, justifiable anger," DeRay McKesson, a 29-year-old protest leader, told Reuters.

Two protests Sunday, which marked the 100th day of demonstrations, were peaceful.

Residents and officials in the region fear another wave of rioting if the grand jury decides not to indict Wilson.

"We are bracing for that possibility. That is what many people are expecting. The entire community is going to be upset," said Jose Chavez, 46, a leader of the Latinos en Axion community group.

For some cities, a decision in the racially-charged case will, inevitably, re-ignite long-simmering debates over local police relations within minority communities.

"It's definitely on our radar," said Lt. Michael McCarthy, police spokesman in Boston, where police leaders met privately Wednesday to discuss preparations. "Common sense tells you the timeline is getting close. We're just trying to prepare in case something does step off, so we are ready to go with it."

In Los Angeles, rocked by riots in 1992 after the acquittal of police officers in the beating of Rodney King, police officials say they've been in touch with their counterparts in Missouri.

"Naturally, we always pay attention," said Commander Andrew Smith, a police spokesman. "We saw what happened when there were protests over there and how oftentimes protests spill from one part of the country to another."

In Las Vegas, police joined pastors and other community leaders this week to call for restraint at a rally tentatively planned northwest of the casino strip when a decision comes.

In Boston, a group called Black Lives Matter, which has chapters in major cities, is organizing a rally in front of the police district office in the Roxbury neighborhood the day after the grand jury's decision.

In Albuquerque, N.M., police are expecting demonstrations after dealing with a string of angry protests following a March police shooting of a homeless camper and more than 40 police shootings since 2010.

Philadelphia police spokesman Lt. John Stanford said he anticipated his city will see demonstrations, regardless of what the grand jury returns.

But big-city police departments stressed they're well-equipped to handle crowds. Many saw large but mostly peaceful demonstrations following the 2013 not-guilty verdict in the case of Florida teen Trayvon Martin, who was shot and killed by neighborhood watch coordinator George Zimmerman. In New York, hundreds of protesters marched from Union Square north to Times Square, where a sit-in caused gridlock.

The New York Police Department, the largest in the nation, is "trained to move swiftly and handle events as they come up," spokesman Stephen Davis said.

In Boston, McCarthy said the city's 2,200 sworn police officers have dealt with the range of public actions, from sports fans spontaneously streaming into the streets following championship victories to protest movements like Occupy.

"The good thing is that our relationships here with the community are much better than they are around the world," he said. "People look to us as a model. Boston is not Ferguson."

Johnson's current employment status is unknown—although he applied for Unemployment benefits in 2014 post-military deployment

Johnson was armed with an SKS rifle and two handguns.

Based on statements by Johnson that there were explosive devices in the area, police swept the area thoroughly and found none.

In TV interviews, the Dallas Chief of Police stated Johnson expressed he was upset about the recent police shootings in Baton Rouge and Minneapolis in verbal exchanges with police during the standoff. The chief also briefed that prior to his death, Johnson stated he had acted alone.

The Dallas Chief of Police explained they used a bomb robot with an attached explosive to approach Johnson, and that Johnson was killed when the device detonated.

A female suspect identified as Niecee Linda CORNUTE was detained near the scene, interviewed, and later released. Name checks revealed no criminal background.

A pair of brothers stopped on Interstate-35 were also questioned and released. The NOC does not yet have their identifying information.

Authorities are weighing whether to treat the shooting of five people protesting near the Minneapolis Police Department's 4th Precinct Monday night as a hate crime, sources familiar with the investigation said Tuesday morning.

[Police are searching for three white men who allegedly fired into a crowd near the Black Lives Matter encampment Monday night.](#) The victims, all black men — ages 19 through 43 — were taken to hospitals with noncritical injuries, according to police.

The shootings occurred at 10:45 p.m. on Morgan Avenue N. about a block north of the precinct station. **Police said via their Twitter feed that they are searching for three white male suspects.**

On Tuesday morning, officials from several agencies met to discuss whether to label the shooting as a hate crime, according to a source with knowledge of the situation.

Miski Noor, a media contact for Black Lives Matter, said “a group of white supremacists showed up at the protest, as they have done most nights.”

One of the men wore a mask, said Dana Jaehnert, who had been at the protest site since early evening.

When about a dozen protesters attempted to herd the group away from the area, Noor said, they “opened fire on about six protesters,” hitting five of them. Jaehnert said she heard four gunshots.

The protesters, angry over the fatal police shooting of 24-year-old Jamar Clark on Nov. 15, have maintained a presence outside the police station ever since.

Those who were shot sustained noncritical injuries, said police spokesman John Elder in a statement.

The gunshot victims were taken to North Memorial Medical Center and Hennepin County Medical Center (HCMC), deputy police chief Medaria Arradondo said at the scene.

A person at the scene said one of the victims had been shot in the stomach, and was undergoing surgery overnight at HCMC.

Expressing concern for the safety of the protesters outside the precinct, Jamar Clark’s brother, Eddie Sutton, urged an end to the encampment.

“Thank you to the community for the incredible support you have shown for our family in this difficult time,” Sutton said in the statement issued early Tuesday. “We appreciate Black Lives Matter for holding it down and keeping the protests peaceful. But in light of tonight’s shootings, the family feels out of imminent concern for the safety of the occupiers, we must get the occupation of the 4th precinct ended and onto the next step.”

Sen. Al Franken said he was “horrified” by news of the shooting.





A demonstrator spoke about his encounter with the assailants who shot five protesters earlier in the night.

“Like all Minnesotans, I was horrified to learn about the shooting of five people outside the Fourth Precinct last night. I understand that a search for the shooters is currently underway, and I join residents of the North Side in demanding that they be brought to justice. In the meantime, my thoughts are with Jamar Clark’s family and the injured.”

Jie Wronski-Riley said the shooting occurred as angry protesters moved the men away from the encampment at the police station. Wronski-Riley heard what sounded like firecrackers and thought, “surely they’re not shooting humans.” Two young black men on either side of him were hit, one in the back and leg, the other in the arm.

At least two of the three men who had been taunting protesters were firing guns, said Wronski-Riley, who described the incident as “really chaotic, really fast.”

“I am obviously appalled that white supremacists would open fire on nonviolent, peaceful protesters,” said Nekima Levy-Pounds, president of the Minneapolis chapter of the NAACP, who returned to the site after the shootings.

Ben Petok, a spokesman for U.S. Attorney Andy Luger’s office, declined to comment on the matter.

Before Monday night’s shooting, BLM had planned a series of events this week.

It has scheduled a news conference Tuesday at 1 p.m. to talk about what was discussed at Sunday night’s community meeting.

The group announced plans for a march at 2 p.m. Tuesday from the 4th Precinct to city hall, the Hennepin County Courthouse and the federal courthouse. A memorial concert is planned for Tuesday night outside the 4th Precinct. A food and clothing drive is planned for Wednesday, and organizers plan a community Thanksgiving on Thursday.





**A Ferguson, Mo., church gutted by fire on Monday was targeted by white supremacists because the pastor had publicly called for Police Officer Darren Wilson to be arrested, Rev. Carlton Lee alleged in an interview.**

Flood Christian Church was one of more than a dozen buildings and businesses damaged by arsonists in the St. Louis suburb overnight after a grand jury chose not to indict Wilson in the shooting death of a black teen.

Lee was an ever-present fixture next to Michael Brown Sr. in the months after his son, Michael Brown Jr., was killed in a violent confrontation with Wilson on Aug. 9. The elder Brown was even baptized at the church on Sunday.

"I'm very vocal in regards to the Michael Brown case," [Lee told NBC News](#).

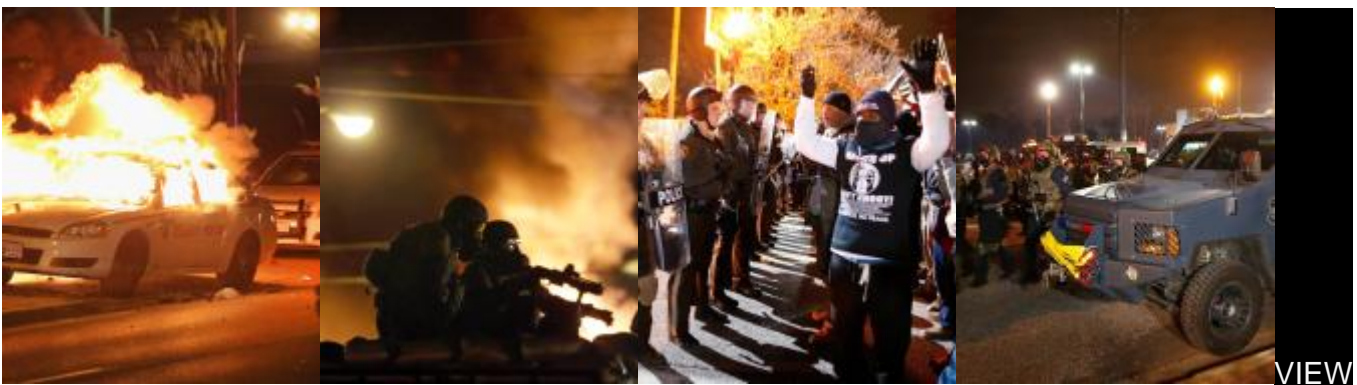
Business owners took a hit Monday, with many buildings getting torched, looted or defaced in some way. Much of the mayhem happened along West Florissant Ave. as a pizzeria and two auto parts stores burned.

But Lee pointed to the distance between his church and the bulk of the violence, calling the burning of his church a targeted crime.

"I was in complete disbelief," Lee said. "I did not believe what I was seeing was fire coming out of the church. I didn't think that anybody would set a church on fire."

He said it's unlikely the people protesting the grand jury's decision are responsible. Instead, racists who wanted to harm the brown family are probably behind the blaze, he said.

"They burned down our church last night but God still reigns," wife [Chanel Lee wrote on Twitter](#).

If Lee's setback feels like revenge, then his fellow merchants express a mix of abandonment and betrayal.

"It's a tragedy. I fault the governor for not giving us the proper protection that we should've had," [Brian Fletcher, chairman of the "I love Ferguson Committee,"](#) told KSDK.

"He promised that at a news conference last week that he'd protect the businesses of Ferguson, he threw us under the bus and ignored us, quite frankly."

Documents obtained by the Intercept establish that the US Department of Homeland Security (DHS) has been spying on Black Lives Matter protesters since anti-police-brutality protests erupted following the police killing of Michael Brown in August 2014.

The Intercept obtained the documents through a Freedom of Information Act request to the DHS's Office of Operations Coordination, which combines information from intelligence and law enforcement agencies to provide "situational awareness" among the DHS agencies. These agencies include the Federal Emergency Management Agency (FEMA), the Transportation Security Administration, and US Customs and Border Protection.

The DHS "frequently collects information, including location data, on Black Lives Matter activities from public social media accounts, including on Facebook, Twitter, and Vine, even for events expected to be peacefu

A white Minnesota man was found guilty of **opening fire and wounding five men** protesting the fatal shooting of a black man by police officers two years ago.

A jury found Allen Scarsella, 24, guilty of 11 counts of assault and one count of riot when he shot and injured five black men, Hennepin County Attorney Mike Freeman said on Wednesday afternoon.

“We are pleased with the jury’s guilty verdict against Allen Scarsella today,” Freeman said in a statement.

“As I said at the time we charged Mr. Scarsella and his companions, the racist language he used in the videos and on social media is just not acceptable and the actions he took as a result of those racist beliefs were heinous. The jury obviously saw it the same way,” Freeman added.

Freeman said prosecutors will be seeking “the stiffest possible sentence” at Scarsella’s sentencing, which is scheduled for March 10. A spokeswoman from the Hennepin County Attorney’s office said prosecutors would likely seek a 19 year sentence for Scarsella.

Protesters had been demonstrating the fatal shooting by police in November 2015 of Jamar Clark, 24, when Scarsella and three other men wearing masks entered a encampment of demonstrators.

All four were arrested and charged. Scarsella admitted to the shootings, prosecutors said in a complaint. During his trial, Scarsella testified he was acting in self defense because he was afraid of being attacked while he was filming the demonstration.

The other three men are facing lesser charges.

Clark was killed during a struggle with Officers Mark Ringgenberg and Dustin Schwarze, who are white. The incident came at a time of intense debate in the United States over police use of force in minority communities.

Last year, authorities announced the two officers would not face charges after an internal investigation determined they did not violate

claimed it was intended to ignite a “race war,” according to media reporting of law enforcement custodial interviews. Roof is currently awaiting trial.<sup>4</sup>

- (U) On February 25, 2012, a white supremacist extremist was sentenced to 40 years in prison for a 2004 package bombing in Arizona that injured Scottsdale’s diversity director and a secretary. At the time of the bombing the perpetrator was associated with White Aryan Resistance<sup>USPER</sup>, a white supremacist extremist group that encourages members to act as “lone wolves” and commit violence against non-whites and the government.<sup>5,6</sup>
- (U) In January 2011, a white supremacist extremist and former member of the neo-Nazi group National Alliance<sup>USPER</sup> placed a bomb along the parade route of the Spokane, Washington MLK Day Parade, with the goal of killing African-American participants. The device was discovered and disarmed.<sup>7</sup> The individual is currently is serving a 32-year prison sentence.<sup>8</sup>

(U//FOUO) Further, the NAACP event will overlap with the RNC in Cleveland, which is scheduled to run 18–21 July, with delegates arriving as early as several days prior to the event. Political conventions such as the RNC historically have attracted domestic terrorist’s intent of taking advantage of these events to commit violent acts. We are concerned (b) (3) (A), (b) (5)

- (U//FOUO) Anarchist extremists used black bloc tactics to violently disrupt the 2008 RNC in St. Paul, Minnesota, causing considerable property damage to the streets surrounding the convention center. Members of an anarchist extremist group called the Republican National Convention Welcoming Committee—some of whom traveled from Austin, Texas—were convicted of firearms charges relating to the construction of Molotov cocktails after an undercover informant revealed the group’s plans to disrupt the event by kidnapping delegates, sabotaging the convention center’s air vents, and capturing federal buildings.<sup>13</sup> Among the items seized by police were gallons of urine, high powered slingshots, a machete, a hatchet, several knives, flammable liquids, axes, bolt cutters, and sledge hammers.<sup>14</sup>

\* (U//FOUO) The GCFC defines “black bloc” tactics as tactics typically carried out by individuals dressed in black and covering their faces to conceal their identity as they commit illegal actions such as vandalism, property destruction, and sometimes acts of violence. These types of tactics appeal to anarchist extremists because they allow anonymity from law enforcement, show solidarity within the movement, and provide public visibility for their cause.

## (U//FOUO) International Terrorism and Homegrown Violent Extremist Threat


(U//FOUO) The GCFC (b) (3) (A), (b) (5)



(U//FOUO) FTOs, such as the self-proclaimed Islamic State of Iraq and the Levant (ISIL) and al-Qa'ida in the Arabian Peninsula, have encouraged HVEs to conduct attacks within the Homeland. These groups use social media to inspire and urge violent extremists to attack targets in the Homeland, including mass gatherings such as the NAACP convention.

- (U//FOUO) In March 2016, social media posting by the ISIL's media company, Al-Wafa, titled "America, You Are Next," pledged to infiltrate the Homeland and carry out attacks, according to open source reporting.<sup>15</sup>
- (U//FOUO) In May 2016, ISIL released an audio message urging its supporters to launch lone wolf attacks against military and civilian targets within the Homeland, according to open source reporting.<sup>16</sup>

## (U//FOUO) Potential Indicators of Suspicious Activities

(U//FOUO) There are numerous behaviors and indicators of potential criminal or violent activities that might be observed at or near the NAACP convention venues. Some of these behavioral indicators may be constitutionally protected activities and should be supported by additional facts to justify increased suspicions. No single behavioral indicator should be the sole basis for law enforcement action. The totality of behavioral indicators and other relevant circumstances should be evaluated when considering any law enforcement response or action. Independently, each indicator may represent legitimate recreational or commercial activities; however, multiple indicators could suggest a heightened threat.

(U//FOUO) Possible behaviors and indicators of planned criminal or violent activity during NAACP Convention events that would arouse the suspicion in a reasonable person include:

- (U//FOUO) Persons attempting to gain unauthorized entry to restricted areas;
- (U//FOUO) Persons discovered with documents highlighting critical areas or infrastructure associated with events without a reasonable explanation or that a reasonable person would find suspicious;

- (U//FOUO) Discreet use of cameras or video recorders, sketching, or note-taking consistent with pre-operational surveillance that a reasonable person would find suspicious;
- (U//FOUO) Unusual observation of or questions about security measures, to include barriers, restricted areas, cameras, or the locations of public safety personnel and equipment;
- (U//FOUO) Persons wearing bulky clothing not consistent with weather conditions;
- (U//FOUO) Bags, containers, or vehicles left unattended near event venues; and
- (U//FOUO) Persons with insignia, symbols, codes, or other regalia utilized by violent neo-Nazi and white supremacist extremists.

### (U) Suspicious Activity Reporting

(U) Suspicious activity is any observed behavior that could indicate criminal activity, terrorism, or terrorism-related crime. This activity includes unusual items or situations, persons asking abnormal or atypical questions about event security, and persons conducting surveillance on the venues.

(U) Reporting suspicious activity can mitigate many threats to the 107th NAACP Convention and associated activities.

(U) For suspicious activity that might have greater implications, the GCFC has a Suspicious Activity Reporting System that can be accessed through the Greater Cincinnati Fusion Center website [www.GCFC.org](http://www.GCFC.org) or by calling the tip-line at 513-263-8000 (Option 1). The GCFC encourages our federal, state, local, and private sector partners to report suspicious activity through either method.
