CALLER AT 16:45 HOURS. THE CALLER STATED, "WHEN NELSON
MANDELA COMES, I'M GOING TO KILL HIM", THEN HUNG UP. NO
FURTHER CALLS WERE PLACED AND THE AHPD HAD NOT RECEIVED ANY

CALLS PRIOR TO THIS ONE WHICH THREATENED MR. MANDELA. AHPD SUBSEQUENTLY NOTIFIED THE DETROIT OFFICE OF THE U.S. SECRET SERVICE AND THE FBI.

AHPD WAS ABLE TO DETERMINE, THROUGH ITS 911 SYSTEM, THAT THE CALL WAS PLACED FROM A PAY TELEPHONE LOCATED WITHIN THE CRIMINAL JUSTICE BUILDING AT OAKLAND COMMUNITY COLLEGE, HAVING THE NUMBER (313) 852-9707. THIS TELEPHONE IS LOCATED IN THE LOBBY OF THE CRIMINAL JUSTICE BUILDING AND IS AVAILABLE FOR PUBLIC ACCESS. DURING THE PERIOD OF TIME IN QUESTION, THE BUILDING WAS OPEN TO THE PUBLIC AND AT LEAST ONE CLASS WAS IN SESSION. THIS BUILDING ALSO HOUSES A GYMNASIUM, WHICH IS OPEN TO THE GENERAL PUBLIC AND STUDENTS.

INVESTIGATION AT DETROIT HAS FAILED TO DETERMINE THE IDENTITY OF THE CALLER.

Dear Sir:

This letter is to confirm a conversation between Assistant United States Attorney (AUSA) of your office and Special Agent of this office on June 20, 1990, at which time the following facts were discussed:

On June 13, 1990, at 16:45 hours the Auburn Hills Police Department (AHPD), Auburn Hills, Michigan, received a call from an anonymous male caller via the AHPD 911 emergency calling system. The caller stated, "When Nelson Mandela comes, I'm going to kill him". The caller then terminated the call.

No further threatening calls regarding Nelson Mandela were placed to AHPD on June 13, 1990, and as of the date of this letter, no other such calls have been received.

Subsequent to receiving the call, AHPD notified the Detroit offices of the FBI, U.S. Secret Service, and the Detroit Police Department (DPD). Investigation by AHPD, DPD, and the FBI determined that the call originated from a pay telephone in the lobby of the Criminal Justice, or "J" Building, at the campus of the Oakland County Community College. The telephone, numbered

(313) 852-9707, is located in the lobby of "J" Building, which is open to the public. Interviews at the scene by AHPD immediately after the incident determined that during the time period the call was placed numerous persons were in the building and the building itself was open to the public. No likely suspects were determined as a result of these interviews.

Based upon the above presentation, [redacted] stated that there is a lack of sufficient investigative leads to continue investigation. The Detroit FBI is conducting no further investigation in this matter.

For the information of the Bureau, on 6/13/90, at 16:45 hours, the AUBURN HILLS POLICE DEPARTMENT (AHPD), Auburn Hills, Michigan, received a call from an anonymous male caller via the AHPD 911 emergency calling system. The caller stated, "When NELSON MANDELA comes, I'm going to kill him". The caller then terminated the call.

No further threatening calls regarding NELSON MANDELA were placed to AHPD on 6/13/90, and as of the date of this airtel, no other such calls have been received.

A presentation of the above facts was made to AUSA [redacted] on 6/20/90 at which time [redacted] stated there was a lack of investigative leads sufficient to continue investigation. This presentation was confirmed in writing by the Detroit FBI in a separate communication to the office of the USA.
