The criminal, racist government of South Africa has declared war on those of its citizens who struggle for a truly democratic society free of the stain of fascist apartheid.

NELSON MANDELA, leader of the African National Congress of South Africa (ANC), remains in prison after serving over 20 years of a life sentence. Most observers agree that Mandela would be elected President in a free South Africa.

WINNIE MANDELA, a leader of the ANC, has spent the entire time since 1963 until today, except for twelve months from September 1975 through August 1976, imprisoned or banned. She is now banned and exiled to the "living grave" of Brandfort, the area of South Africa known to be the most racist and conservative.

Freedom fighters Simon Mogoerane, Jerry Mosololi, and Thabo Motaung, members of the ANC, were hanged by the South African government in June, 1983. They are three in a long list of prisoners of war executed and awaiting execution in violation of international law and human decency.

We join with the United Nations, the Organization of African Unity, and millions of our own people in calling for the immediate, unconditional release of Nelson and Winnie Mandela and all South African freedom fighters captured by the illegal regime.

President Reagan, we call upon you to demonstrate the full support of our government for these demands.

The National Alliance Against Racist and Political Repression (NAARPR) has issued the above petition calling for freedom for Nelson and Winnie Mandela and all South African political prisoners and an end to apartheid executions. It calls for President Reagan to demonstrate full support from our government for these demands. Petitions and a pamphlet on the issue are available from the NAARPR. A "peoples' gram" to Reagan condemning the "high treason" trials of eight leaders of the United Democratic Front of South Africa and demanding their immediate release is also available.
