ON JULY 7, 1993, NELSON MANDELA TRAVELED TO THE WEST SIDE OF CHICAGO IN ORDER TO GIVE A SPEECH AT THE PLUMBER'S HALL LOCATED AT THE CORNER OF RACINE AND WASHINGTON AVENUES, CHICAGO, ILLINOIS. SECURITY FOR MANDELA WAS PROVIDED BY THE U.S. SECRET SERVICE, U.S. DEPARTMENT OF STATE-DIPLOMATIC SECURITY, AND THE CHICAGO PD-INTELLIGENCE DIVISION. TO BE REGISTERED SUBSEQUENT TO STATEMENT THAT IT WAS REGISTERED. AT THIS POINT. WAS APPRISED OF HIS CONSTITUTIONAL RIGHTS, AND AFTER A BRIEF CONVERSATION, AGREED TO SIGN A "CONSENT TO SEARCH", AND THE OFFICERS CONDUCTED A SEARCH OF THE PREMISES, WHICH REVEALED A PAIR OF BINOCULARS FOUND BY AN OPEN WINDOW, AS WELL AS ONE BLOW-GUN. AND ONE CROSS-BOW. FURTHER SEARCH REVEALED A PAIR OF NUNCHUKS, HUNTING KNIFE AND TWO SWORDS. THESE ITEMS/WEAPONS WERE ALSO SEIZED. INDICATED THAT HE DEPLORES WEAPONS, BUT KEEPS THE RIFLE AROUND TO PROTECT HIMSELF FROM THE GANGS THAT ARE "TERRORIZING" HIS NEIGHBORHOOD. IT SHOULD BE NOTED THAT THIS AREA IS HIGHLY INDUSTRIALIZED, AND THE CHICAGO POLICE CONSIDER THIS AREA NOT TO BE AN AREA OF HEAVY GANG CONCENTRATION.

FURTHER INVESTIGATION BY THE CHICAGO POLICE REVEALED THAT A SURVEILLANCE CAMERA WAS LOCATED IN A BEDROOM/WORK AREA OF

APARTMENT. A MONITOR AND CONTROL BOX WERE ALSO LOCATED IN ANOTHER ROOM INSIDE THE RESIDENCE. FOLLOWING THE CURSORY SEARCH OF THE APARTMENT, AND ALL SEIZED EVIDENCE WAS SUBSEQUENTLY TRANSPORTED TO THE 12TH DISTRICT AND AREA 4 (CHICAGO PD) FOR PROCESSING. ALL EVIDENCE SEIZED WAS INVENTORIED BY AREA 4 AND SUBMITTED TO THE CRIME LAB AND EVIDENCE/RECOVERED PROPERTY SECTION.

SEIZED RIFLE WAS AN SKS, CHINESE ORIGIN, 7.62 RIFLE WITH A FOUR-INCH BLUE BARREL, SERIAL NUMBER 1401079. ALSO SEIZED WITH THE SKS RIFLE WAS ONE RIFLE CASE AND 60 LIVE ROUNDS OF 7.62 FULL METAL JACKET AMMUNITION.
