telephone number [redacted] was contacted by SA [redacted]  
wherein he voluntarily provided the following information:

[redacted] advised the USSS does and has worked with the DETROIT  
POLICE DEPARTMENT (DPD) pertaining to protection matters wherein the  
USSS has jurisdiction. Where the USSS does have jurisdiction, the  
USSS pays for all expenses for their protectees, to include lodging  
and transportation, even if they are assisted by DPD. Where assisted  
by DPD, DPD is responsible for their own expenses, such as additional  
manpower and overtime; however, [redacted] was unaware how these expenses  
would be funded.

According to [redacted] an outside contract security service,  
believed to be the BUREAU OF DIPLOMATIC SECURITY, was responsible for  
the protection of a [redacted] who was relocated to the Detroit  
area a couple of years ago by the DRUG ENFORCEMENT ADMINISTRATION.  
The USSS was not involved in any way with the protection of [redacted]

to pay for expenses associated with DPD protection details. DPD has  
assisted the USSS on numerous occasions with USSS protection details

[redacted] UNITED STATES SECRET SERVICE, Detroit, Michigan, telephone number [redacted] was interviewed by SA [redacted] FEDERAL BUREAU OF INVESTIGATION, Detroit, Michigan. Upon being advised of the nature of the interview and the identity of the interviewing Agent, [redacted] provided the following:

[redacted] stated regarding the visit of Pope JOHN PAUL II to Detroit in September, 1987, the DETROIT POLICE DEPARTMENT (DPD) would have been paid regular salary and would not have been reimbursed by the SECRET SERVICE for any overtime. The equipment used by the Secret Service during this visit was rented, such as tents and the Secret Service did not receive any money or any cash from the DPD for any rentals, equipment, or any other materials when the Pope visited Detroit in 1987. According to [redacted] the usual visits the Secret Service protects are smaller than the visit of the Pope. The UNITED STATES SECRET SERVICE uses the DPD [redacted] and bikes as this equipment is already in the possession of the DPD and the equipment is available. When the DPD assists the Secret Service, it is a joint effort and there is no exchange of money between the two agencies. [redacted] stated the local office of the Secret Service did not have a file containing the names of the 1984 candidates for President who visited Detroit.

[redacted] recalled Lieutenant [redacted] DPD, currently retired, was in charge of the Pope's visit in 1987.

[redacted] stated DPD does not assist the Secret Service with any SWAT or Counter Sniper matters for protection as the Secret Service brings its own people in for these situations. Further, [redacted] stated the UNITED STATES SECRET SERVICE did not have anything to do with the visit of NELSON MANDELLA to the Detroit area.
