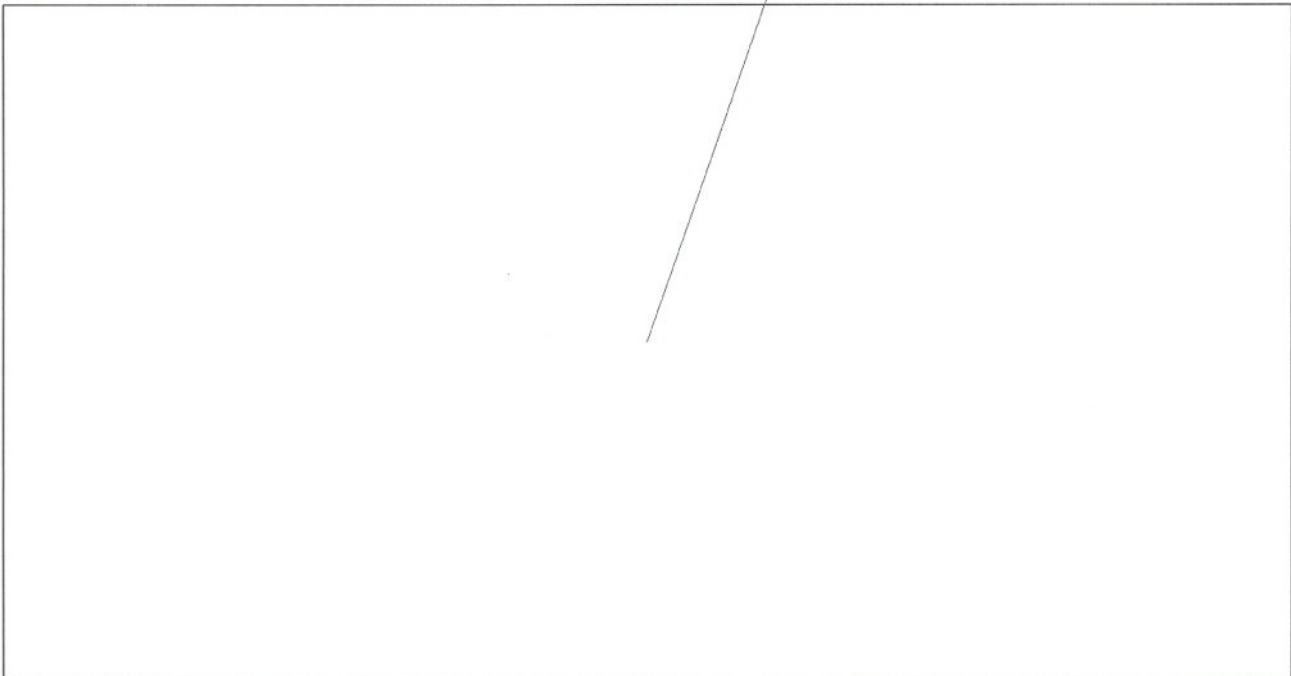

((NYANDA)), SAID HE WAS CONFIDENT THAT THE TROOPS DEPLOYED WERE WELL-PREPARED FOR THE MISSION THEY HAD BEEN GIVEN, BUT NEVERTHELESS HAD CONTINGENCY PLANS IN PLACE TO ENSURE THE SAFETY OF THE TROOPS IF THINGS DID NOT TURN OUT AS HE WOULD HAVE LIKED THEM." END QUOTE.
