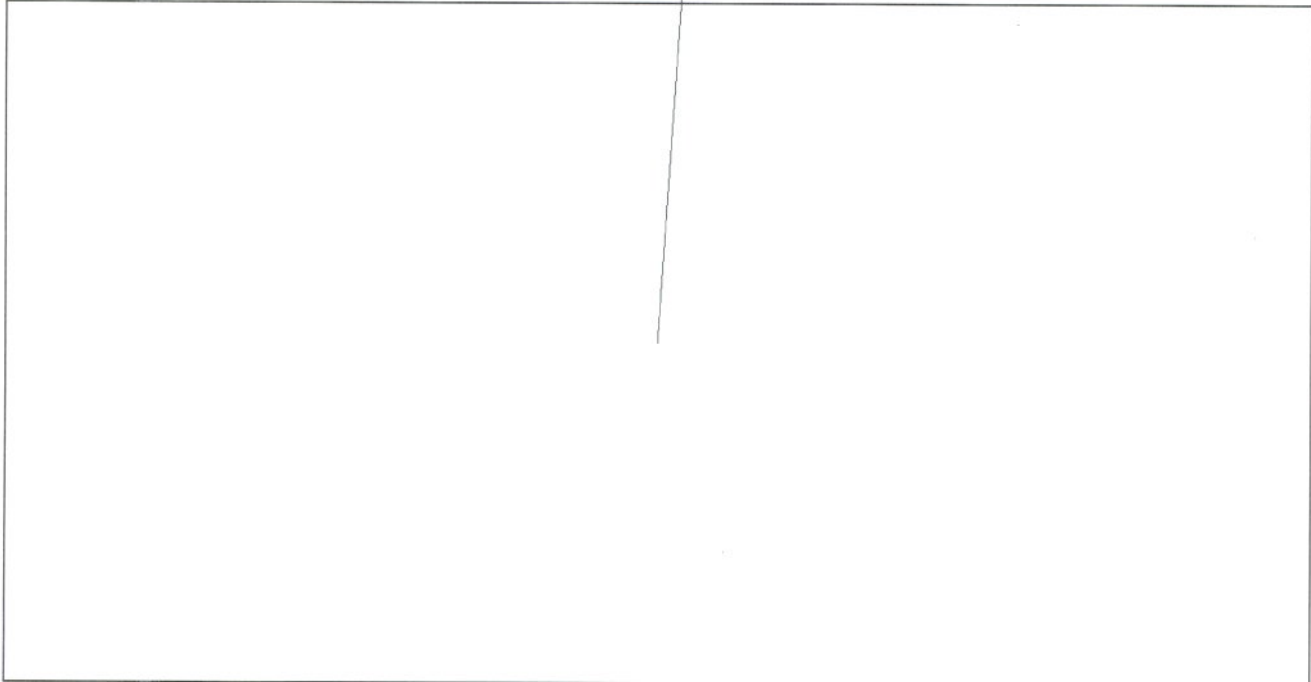

2. (U) BEGIN QUOTE - "THE GOVERNMENT OF THE UNITED
REPUBLIC OF TANZANIA HELD DISCUSSIONS WITH THE MOVEMENT
CONSEIL NATIONAL POUR LA DEFENSE DE LA DEMOCRATIE - FORCES
POUR LA DEFENSE DE LA DEMOCRATIE (CNDD-FDD) FROM 28 MAY TO
3 JUNE 2002 AT THE WHITE SANDS HOTEL IN DAR ES SALAAM, ON
THE PREPARATION FOR NEGOTIATIONS WITH A VIEW TO FINDING
WAYS AND MEANS FOR A DEFINITIVE CESSATION OF HOSTILITIES
AND THE TOTAL RESOLUTION OF THE CONFLICT IN BURUNDI, THE
CEASE FIRE FORMING AN INTEGRAL PART OF THE RESOLUTION.
THIS WAS A FOLLOW-UP MEETING TO THE EARLIER MEETING HELD AT
THE SAME VENUE FROM 13 TO 20 MARCH 2002.
3. (U) AMBASSADOR M.W. ((MANGACHI)) LED THE TANZANIA
GOVERNMENT DELEGATION, AND MR. RADJABU ((HUSSEIN)), THE
SECRETARY GENERAL OF CNDD-FDD, LED THE CNDD-FDD DELEGATION.
THE TANZANIAN MINISTER FOR FOREIGN AFFAIRS AND
INTERNATIONAL COOPERATION, HONORABLE JAKAYA MRISHO
((KIKWETE)), ATTENDED THE OPENING SESSION OF THOSE TALKS
AND DELIVERED THE OPENING SPEECH.
4. (U) AFTER DISCUSSING THE MODALITIES FOR A
COMPREHENSIVE CEASEFIRE, CNDD-FDD EXPRESSED ITS READINESS
AND COMMITMENT TO UNDERTAKE CEASEFIRE TALKS WITH THE
POLITICO-MILITARY LEADERSHIP IN BURUNDI AS SOON AS
POSSIBLE. FURTHERMORE, IT STRESSED THAT, LIKE IN ALL
NEGOTIATIONS, CEASEFIRE ISSUES SHOULD FORM AN INTEGRAL PART
OF THE AGENDA OF THE NEGOTIATIONS.

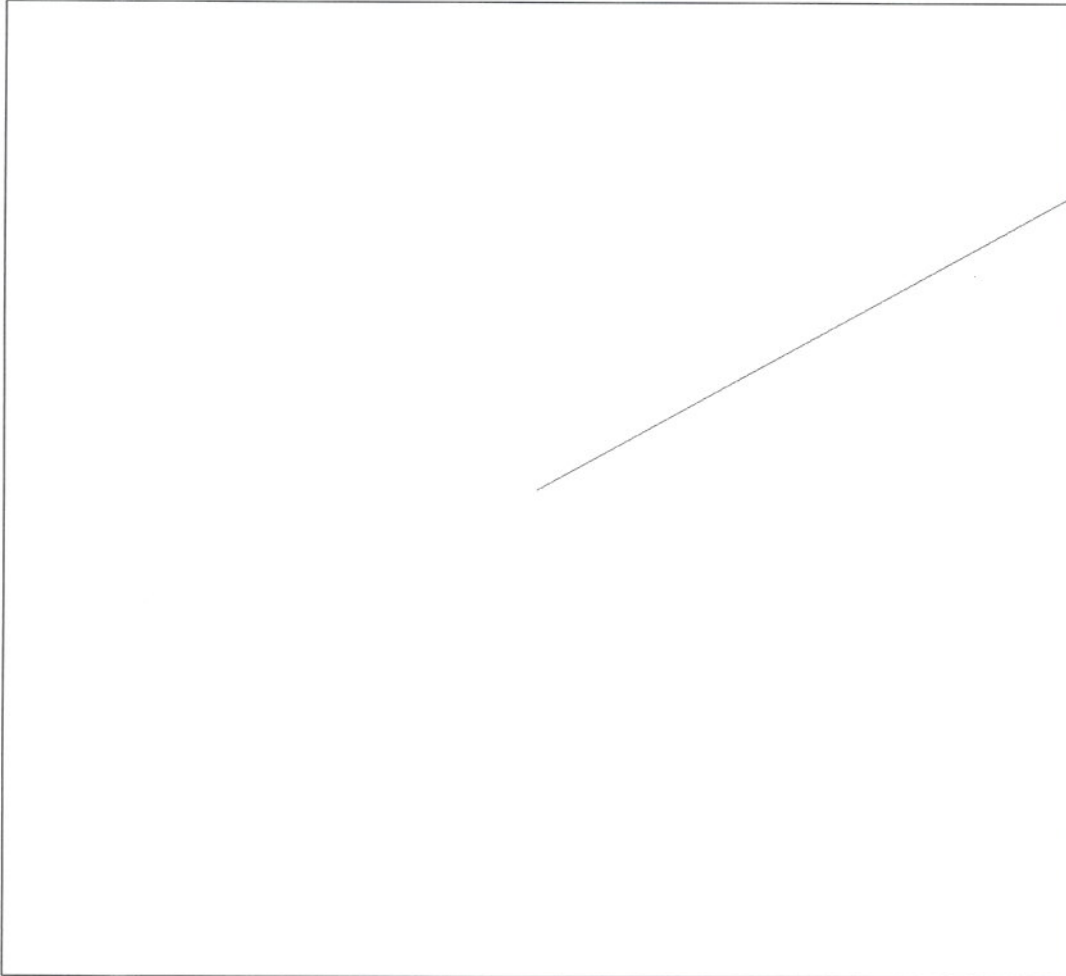

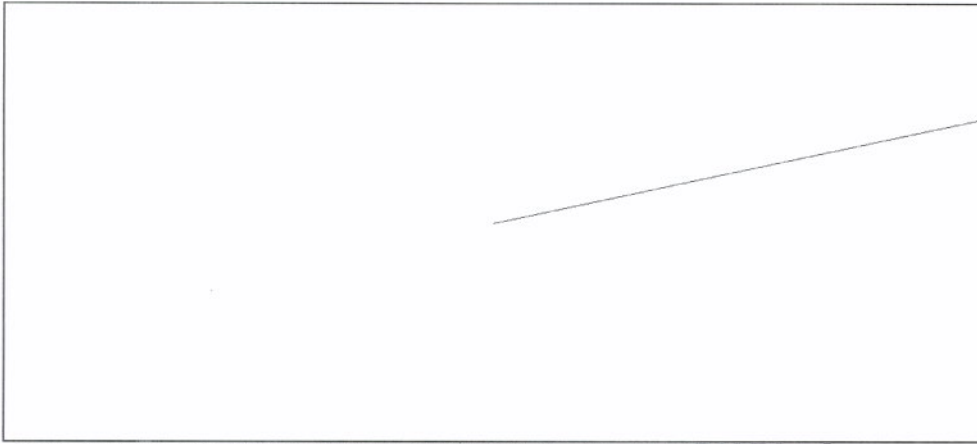

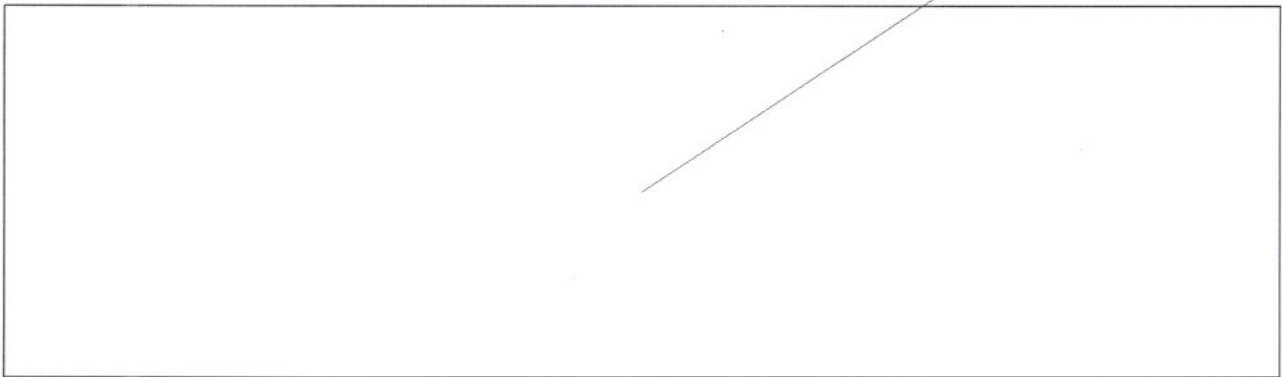
