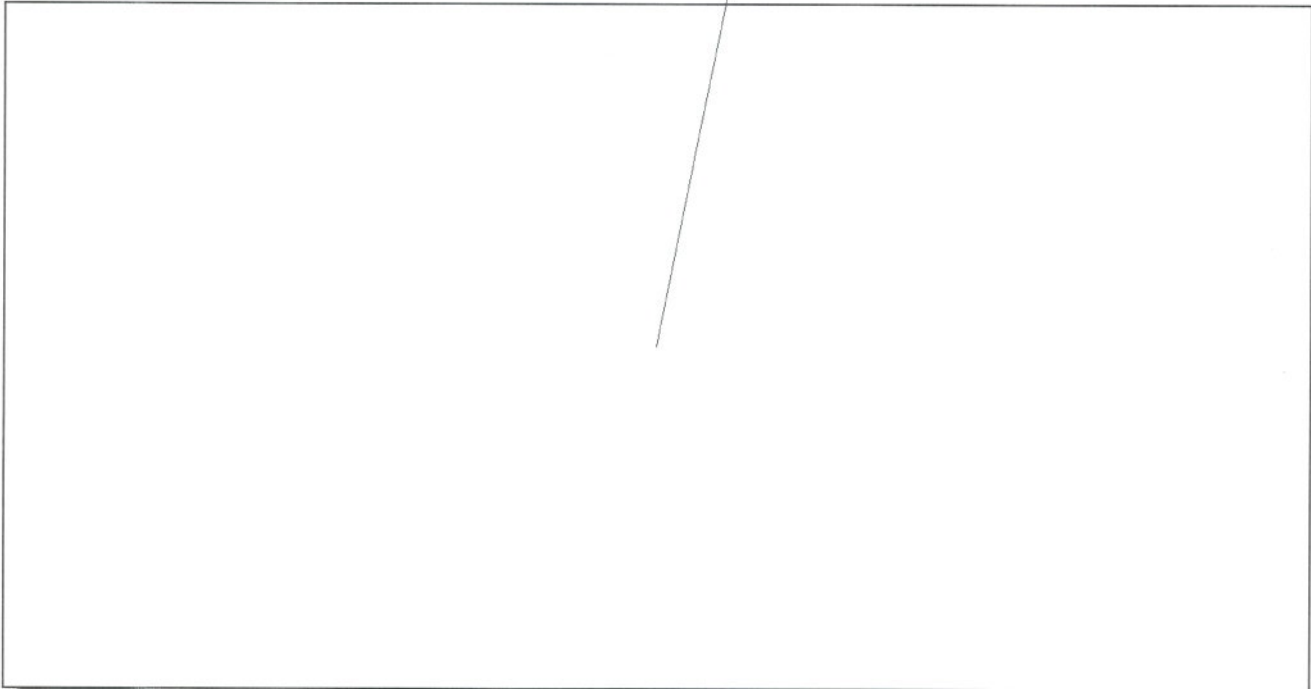

TEXT: 1. ~~(C/NF)~~ INTRODUCTION. THE FOREIGN INTEREST IN SOUTH AFRICA'S 1999 ELECTION FOCUSES FIRST ON THE SITUATION IN THE RUN-UP TO THE ELECTION AND ON ELECTION DAY. SECOND, IT FOCUSES ON THE FOREIGN ROLE-PLAYERS' VIEW AND PERCEPTIONS REGARDING THE POST-ELECTION PERIOD. THE MOST PROMINENT ISSUES ARE INVESTOR CONFIDENCE AND A THABO ((MBEKI))-LED GOVERNMENT'S ABILITY TO GOVERN THE COUNTRY. 2. (U) FOREIGN INTEREST IN PRE-ELECTION PERIOD.

B. ~~(C/NF)~~ THE ORGANIZATION FOR AFRICAN UNITY (OAU) ALSO WANTS TO SEND ELECTION OBSERVERS TO M ONITOR THE PROCESS. SENIOR OAU STAFF BELIEVE THAT THE SUCCESSFUL CONCLUSION OF ELECTIONS IN 1999 IN TWO OF AFRICA'S MOST IMPORTANT COUNTRIES, SOUTH AFRICA AND NIGERIA, WILL BE A POSITIVE DEVELOPMENT FOR AN OTHERWISE RESTLESS AND UNSTABLE CONTINENT.

C. ~~(C/NF)~~ BRAZILIAN SECRETARY-GENERAL OF FOREIGN AFFAIRS, SEIXAS ((CORREIA)) RECENTLY INDICATED THAT BRAZIL DID NOT ANTICIPATE ANY PROBLEMS DURING OR AFTER THE ELECTION. HE ALSO ADDED THAT BRAZIL

D. ~~(C/NF)~~ ALTHOUGH FOREIGN ROLE-PLAYERS AND NON-GOVERNMENTAL OBSERVERS HAVE NOT EXPRESSED ANY NOTEWORTHY CONCERN REGARDING VIOLENCE IN THE RUN-UP TO THE ELECTION, THE SAME CAN NOT BE SAID OF THE INTERNATIONAL MEDIA. A REUTERS OPINION POLL PUBLISHED ON 9 APRIL 1999, STATED THAT POLITICALLY MOTIVATED VIOLENCE IS LIKELY TO MAR THE ELECTION. THE POLL SHOWED THAT KWAZULU-NATAL, WESTERN CAPE AND EASTERN CAPE WERE THE PROVINCES MOST LIKELY TO EXPERIENCE POLITICALLY MOTIVATED VIOLENCE.

E. ~~(C/NF)~~ NO INFORMATION HAS BEEN RECEIVED OF ANY FOREIGN SUPPORT TO ORGANIZATIONS OR INDIVIDUALS PLANNING TO DISRUPT THE ELECTION OR TO LAUNCH AN ANTI-ELECTION CAMPAIGN.

B. ~~(C/NF)~~ OTHER COUNTRIES WITH POSITIVE VIEWS, INCLUDE MAURITIUS AND RUSSIA. BOTH THE MAURITIUS GOVERNMENT AND THE OPPOSITION EXPECT BILATERAL RELATIONS TO STRENGTHEN UNDER MBEKI'S LEADERSHIP. THE RUSSIAN FOREIGN MINISTRY DOES NOT FORESEE ANY CHANGES IN RELATIONS WITH SOUTH AFRICA IN THE SHORT TERM. RUSSIA WOULD, HOWEVER, LIKE TO SEE INCREASED COOPERATION WITH SOUTH AFRICA ON ECONOMIC ISSUES AND WOULD ALSO LIKE TO SEE THAT IMPORTANT ISSUES SUCH AS THE CRIME AND VIOLENCE IN THE COUNTRY ARE ADDRESSED.

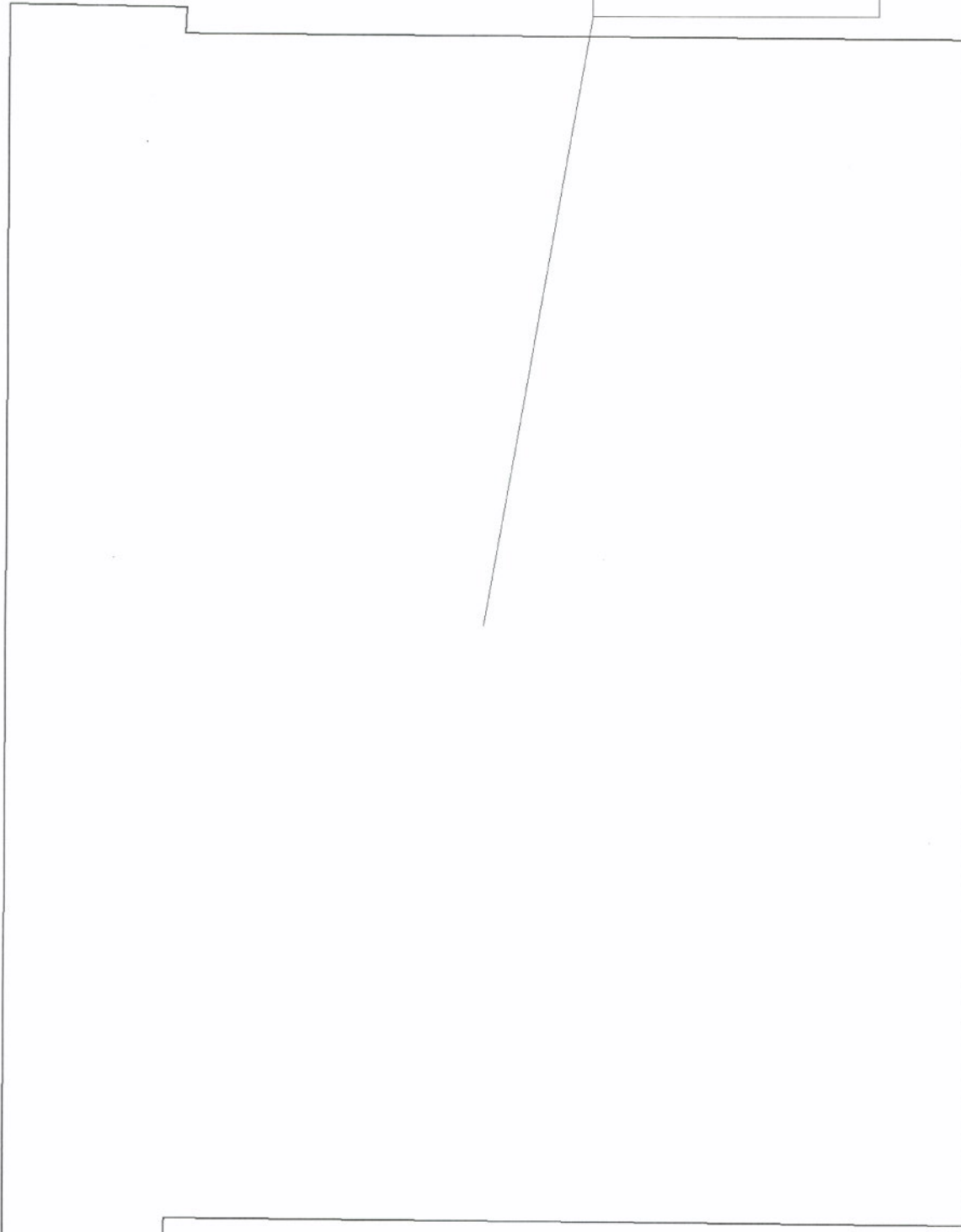

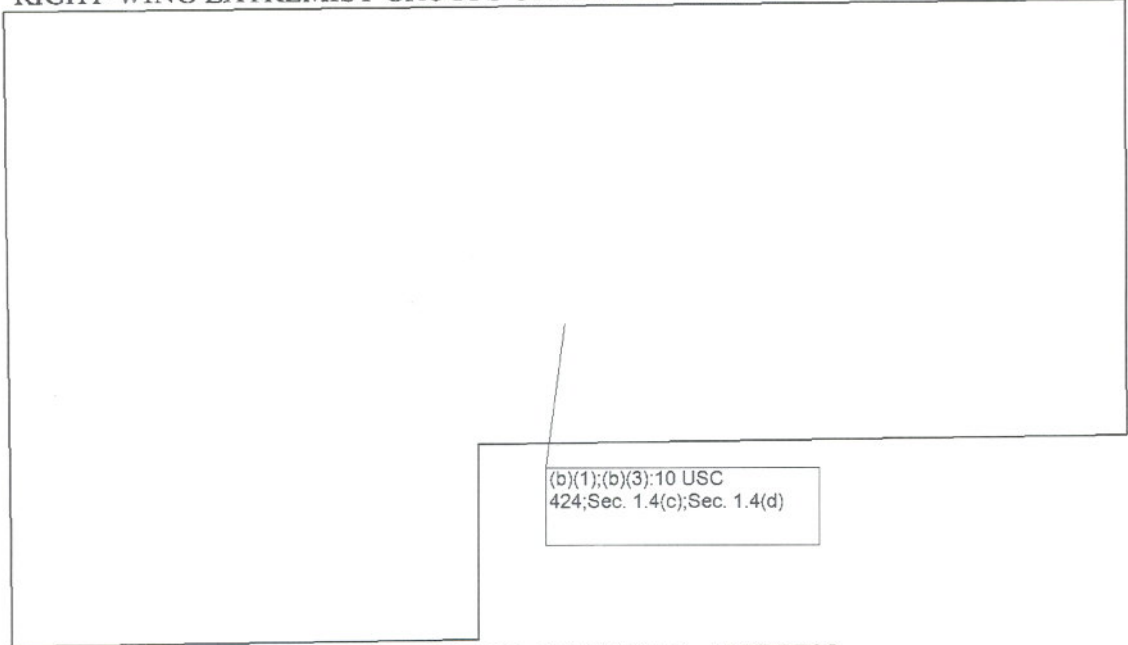
5. ~~(C/NF)~~ CONCLUSION. CURRENT INFORMATION DOES NOT INDICATE ANY THREAT OR RISK OF A FOREIGN NATURE TO THE ELECTION. HOWEVER, THERE ARE A FEW ISSUES OF CONCERN THAT WILL NEED CONSTANT MONITORING. THE MOST IMPORTANT OF THESE IS THE SECURITY SITUATION IN LESOTHO. IF LARGE-SCALE UNREST AND RIOTING BREAK OUT AGAIN IN LESOTHO, IT

 WILL HAVE TO PROCESS THE REFUGEES' DOCUMENTATION, UNDER
 INCREASING
 STRAIN AS IT IS ALREADY OVERBURDENED WITH THE PROCESSING OF BAR-
 CODED
 ID DOCUMENTS BEFORE THE ELECTIONS. DURING THE 1994 ELECTION,
 RIGHT-WING EXTREMISM AND THE SUPPORT IT RECEIVED FROM FOREIGN
 SOURCES
 WERE SEEN AS A REAL THREAT TO THE ELECTION. HOWEVER, NO
 INFORMATION
 HAS BEEN RECEIVED UP TO NOW INDICATING ANY FOREIGN SUPPORT TO
 RIGHT-WING EXTREMIST GROUPS OPPOSED TO THE ELECTION.
