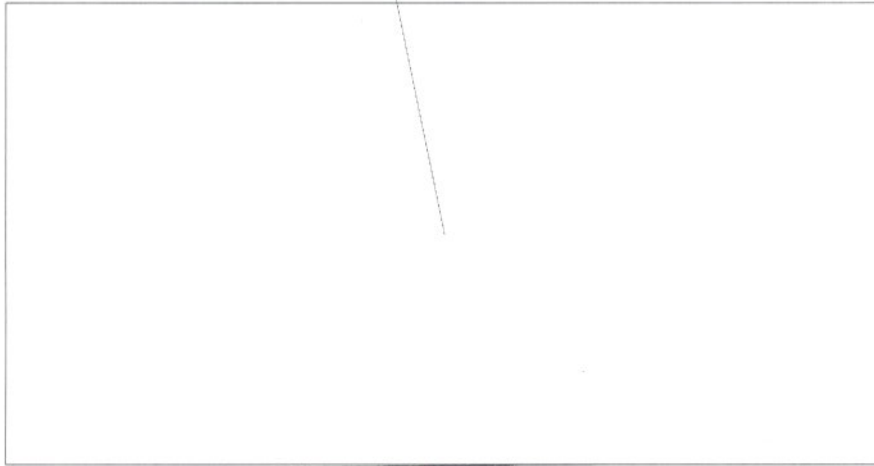

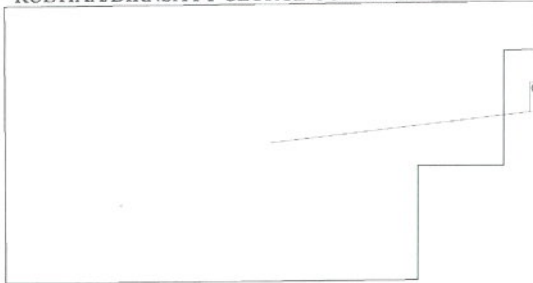

SUMMARY: (U) A MANDATE FOR THE AFRICAN UNION MISSION IN
BRUNDI IS CONTINGENT UPON THE RATIFICATION OF THE "PROTOCOL
RELATING TO THE ESTABLISHMENT OF THE PEACE AND SECURITY
COUNCIL OF THE AFRICAN UNION." TWO-THIRDS OF MEMBER STATES
MUST RATIFY IT, ONLY ONE HAS SIGNED.

[REDACTED] NELSON MANDELA USED HIS PERSONAL CLOUT TO ARRANGE A BILATERAL AGREEMENT BETWEEN BURUNDI AND SOUTH AFRICA TO PROTECT HIS POLITICAL FRIENDS WHO WANT TO RETURN TO BURUNDI. HOWEVER, [REDACTED] THE AU IS CONSIDERING ASKING SOUTH AFRICA TO CHANGE THE MANDATE OF ITS 700-MAN FORCE IN BURUNDI TO PROTECT EXILED POLITICAL LEADERS RETURNING TO THE COUNTRY, TO A AU PEACEKEEPING MANDATE. [REDACTED] WOULD PRECLUDE THE NEED FOR SOUTH AFRICA TO SEND ANOTHER BATTALION OF PEACEKEEPERS TO BURUNDI.
