UNRELATED TO CBW, PRESIDENT MANDELA PUBLICLY ACKNOWLEDGED IN MARCH 1995 THAT SOUTH AFRICAN SCIENTISTS MAY HAVE BEEN WORKING IN LIBYAN CBW PROGRAMS WITHOUT GOVERNMENT APPROVAL FOLLOWING BASSON'S ARREST, CHEMISTS INVOLVED IN PROJECT COAST BEGAN TO COOPERATE WITH AUTHORITIES BECAUSE OF CONCERN ABOUT WHAT BASSON MIGHT HAVE REVEALED AT LEAST ONE CHEMIST CONFIRMED THAT SOUTH AFRICAN CW TECHNOLOGY WAS SOLD TO LIBYA WITHOUT THE KNOWLEDGE OF THE MANDELA GOVERNMENT. SALES OF CHEMICAL WEAPONS TO IRAN AND IRAQ ALSO MAY HAVE OCCURRED. }}}}

4. (U) BACKGROUND OF THE SOUTH AFRICAN CBW PROGRAM. SOUTH AFRICA DEVELOPED ITS CBW PROGRAM WITH LITTLE OPEN FOREIGN ASSISTANCE. ALTHOUGH SOUTH AFRICA HAS ADMITTED TO DEVELOPING A CBW DEFENSE PROGRAM, COAST WAS THE FOCUS FOR OFFENSIVE CAPABILITIES USING THE 7TH MEDICAL BATTALION AS ITS OPERATIONAL ARM. AS A BRIGADIER, DR BASSON ALSO COMMANDED THE 7TH MEDICAL BATTALION. ACCORDING TO A REPORT BY CIVILIAN DEFENCE SECRETARY PIERRE STEYN, THE 7TH MEDICAL SUPPLIED CHEMICAL POISONS TO ASSASSINS IN SADF HIT SQUADS AND USED CW AGAINST MOZAMBIQUE LIBERATION FRONT (FRELIMO) TROOPS DURING THE MOZAMBIQUE CIVIL WAR IN THE LATE 1980S. STEYN WAS DIRECTED TO INVESTIGATE AND REPORT ON UNCONTROLLED VIOLENCE THAT OCCURRED IN PARTS OF SOUTH AFRICA AS APARTHEID WAS ENDING. BOTH PRESIDENT DE KLERK AND NELSON MANDELA RECEIVED THE REPORT BEFORE THE 1994 POSTAPARTHEID ELECTIONS.
